Proposed Rules of Procedure Change

Mr. President:

I move to amend the 2019-2023 Metropolitan Council Rules of Procedure by amending Rule 28 as shown below:

28. Public addressing Council

During the public comment period held at the second regular Council meeting of each month, and at the discretion of the Vice Mayor, individuals shall be allowed to speak for up to two (2) minutes each.

During all other public hearings, individuals shall be allowed to speak for up to two (2) minutes regarding each matter.

Members of the public may address the Council in a public hearing format regarding a specific resolution or ordinance, when a public hearing is not otherwise required by law, if the Council approves a Council member's motion by a two thirds (2/3) simple majority vote of the Council members present at such meeting to allow members of the public to address the Council. Such motion shall specify the subsequent meeting at which the public hearing is to take place.

The Clerk shall keep time in accordance with this rule.

SUBSTITUTE RESOLUTION NO. RS2022-1348

A Resolution honoring the life of Dr. Mr. Yusef Harris.

WHEREAS, longtime Jefferson Street business owner Dr. Mr. Yusef Harris died earlier this month at the age of 66; and

WHEREAS, Dr. Mr. Harris opened Nashville's first Black bookstore, Alkebu-Lan Images, in 1986 while pursuing his doctorate in psychology at Vanderbilt University and teaching part-time at Tennessee State University. He was able to purchase the property, which he credited with the success of the business; and

WHEREAS, Alkebu-Lan has been a cornerstone of the North Nashville community for more than 35 years. The shop sells books, art, apparel, and other goods that reflect and celebrate African culture; and

WHEREAS, Dr. Mr. Harris encouraged people to read more and to be conscious of their culture, heritage, and history, especially African-Americans. He was a promoter and advocate of education and he specialized in Children's books to ensure that the African American history was known for generations to come; and

WHEREAS, to many, Alkebu-Lan felt like a home away from home. His son, Jordan, worked in the store at a young age and eventually became his business partner as they invested in other properties throughout the North Nashville community, ensuring the Black presence would never be forgotten; and

WHEREAS, Dr. Mr. Harris mentored and advised hundreds of Black business owners and is remembered for hosting poets and spoken-word artists at open-mic nights and storytelling for children; and

WHEREAS, Dr. Mr. Harris was a beloved member of the Nashville community, impacted thousands of lives with his commitment to uplift positive images of Black people, and was an anchor in North Nashville; and

WHEREAS, it is fitting and proper that the Metropolitan County Council honor and remember the life of Dr. Mr. Yusef Harris.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. That the Metropolitan Council hereby goes on record as honoring the life of Dr. Mr. Yusef Harris.

Section 2. This Resolution shall take effect from and after its adoption, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

WHEREAS, 13 players were named to the All-Region Team: Lamonte Shute, Chazell Atkins, Jerry Campbell, Damon Webb, DeMyius Trotter, Zack Beard, Frank Gordon, Emarius Hyde, LaDon Pointer, Malik Boling, Willie Wilson, Kaymon Overton, and Amarion Ford; and

WHEREAS, three players were named to the 3A All-State Team: Jerry Campbell, Frank Gordon, and Amarion Ford; and

WHEREAS, Running Back Coach Kelsea Fordham coached his first 2,000-yard running back; and

WHEREAS, Strength and Conditioning Coach Stephon Chambliss played a big part in helping the team stay healthy and accomplish so many accolades; and

WHEREAS, Head Coach Jamaal Stewart was recognized as Medium Class Coach of the Year by 615 Preps. Coach Stewart teaches kids more than being great football players, he always teaches student-athletes how to become young men.

AMENDMENT NO. 1

Mr. President -

I hereby move to amend Ordinance No. BL2021-961 by amending Section 1, proposed Metropolitan Code of Laws Section 13.08.080.G.12 as follows:

12. An LPR technology deployment policy shall be developed and implemented by the MNPD to help prevent misuse of LPR technology to track and unfairly target vulnerable communities. Placement of fixed LPR technology in the public right of way shall be limited to major and collector streets as defined in the Nashville Next Major and Collector Street Plan, and the location of LPR devices shall be distributed equitably across the north, south, east, and west quadrants of the county. Signage shall be placed by any fixed LPR technology to give notice to the public of the use of such technology at a given location. The signage shall be clearly visible and legible to the motoring public and shall state "License Plate Reader Technology In Use".

This shall not limit the Metropolitan Government's ability to accept a grant from a governmental entity.
