## AMENDMENT NUMBER 2 TO CONTRACT NUMBER 422573 BETWEEN THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY AND INFOR (US), INC.

## **WITNESSETH**

*WHEREAS*, the parties desire to modify the terms and conditions and to add or delete certain other terms and conditions to their original agreement dated August 22, 2018, Metro Contract numbered 422573, hereinafter the "CONTRACT", the parties hereby agree as set forth below:

This amendment affects the following changes to the contract:

1. Amend section 3.1 Contract Term to extend for an additional twelve (12) months to reflect the contract term as forty-eight (48) months. Section shall read as follows:
