

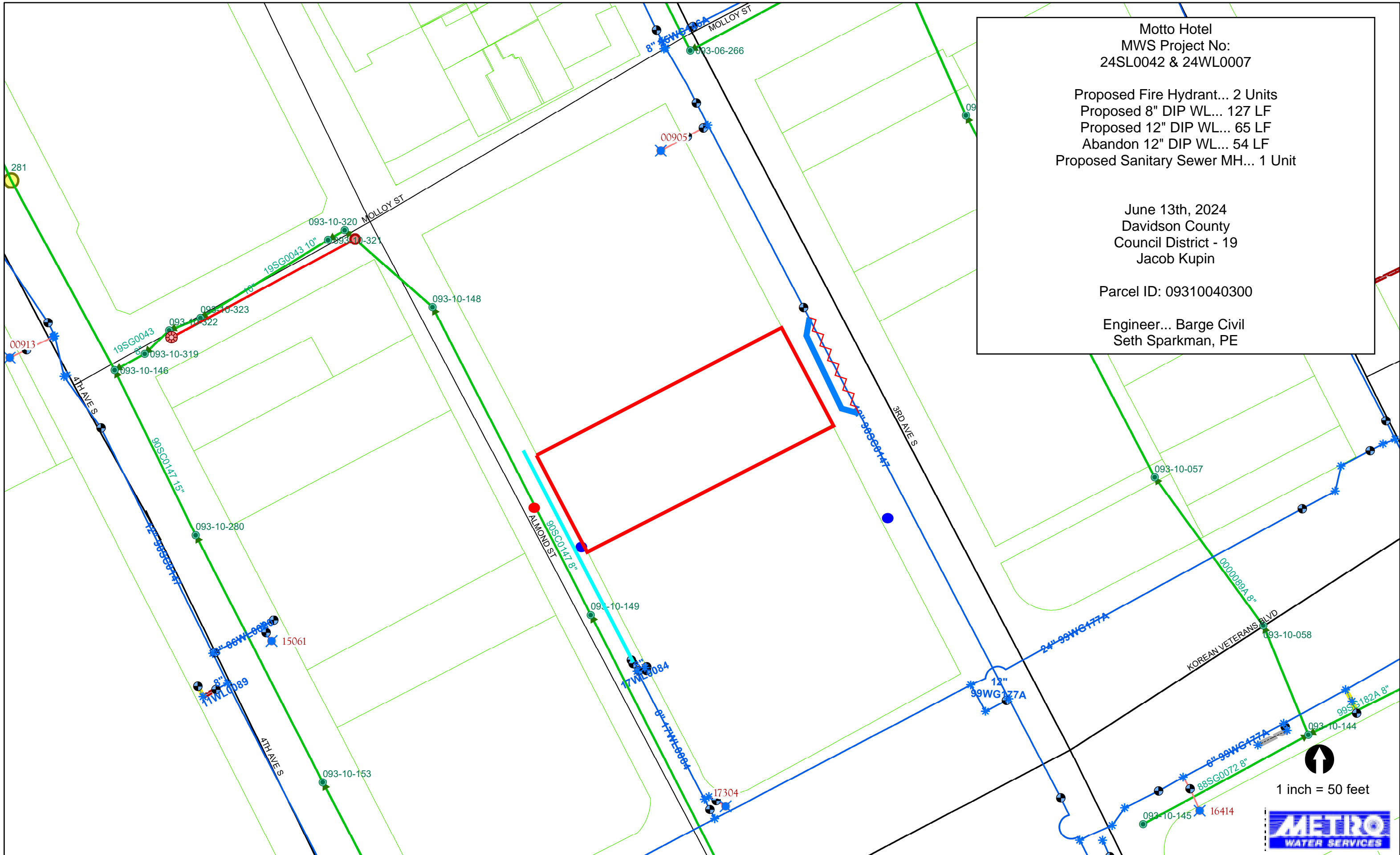

On behalf of the Metropolitan Planning Commission, the following item, referred to the Commission as required by the Metro Charter, has been recommended for *approval* to the Metropolitan Council:

A request to amend Council ordinance BL2024-368 and Proposal No. 2024M-053ES-001 for the purpose of abandoning approximately 54 linear feet of 12-inch water main and accepting approximately 65 linear feet of new 12-inch water main (DIP). Specific infrastructure instead now will be the abandonment of approximately 54 linear feet of 12-inch water main and the acceptance of approximately 65 linear feet of new 12-inch water main, approximately 127 linear feet of new eight-inch public water main (DIP), two new fire hydrant assemblies, and one sanitary sewer manhole to serve the Motto Hotel Revision 1 development.

The relevant Metro agencies (Metro Parks, Nashville Department of Transportation, Metro Water Services, Metro Emergency Communications, the Nashville Electric Service, Metro Finance – Public Property and the Metro Historical Commission) have reviewed the proposal and concur in the recommendation for approval. This request must be approved by the Metro Council to become effective. A sketch showing the location of the request is attached to this letter.
