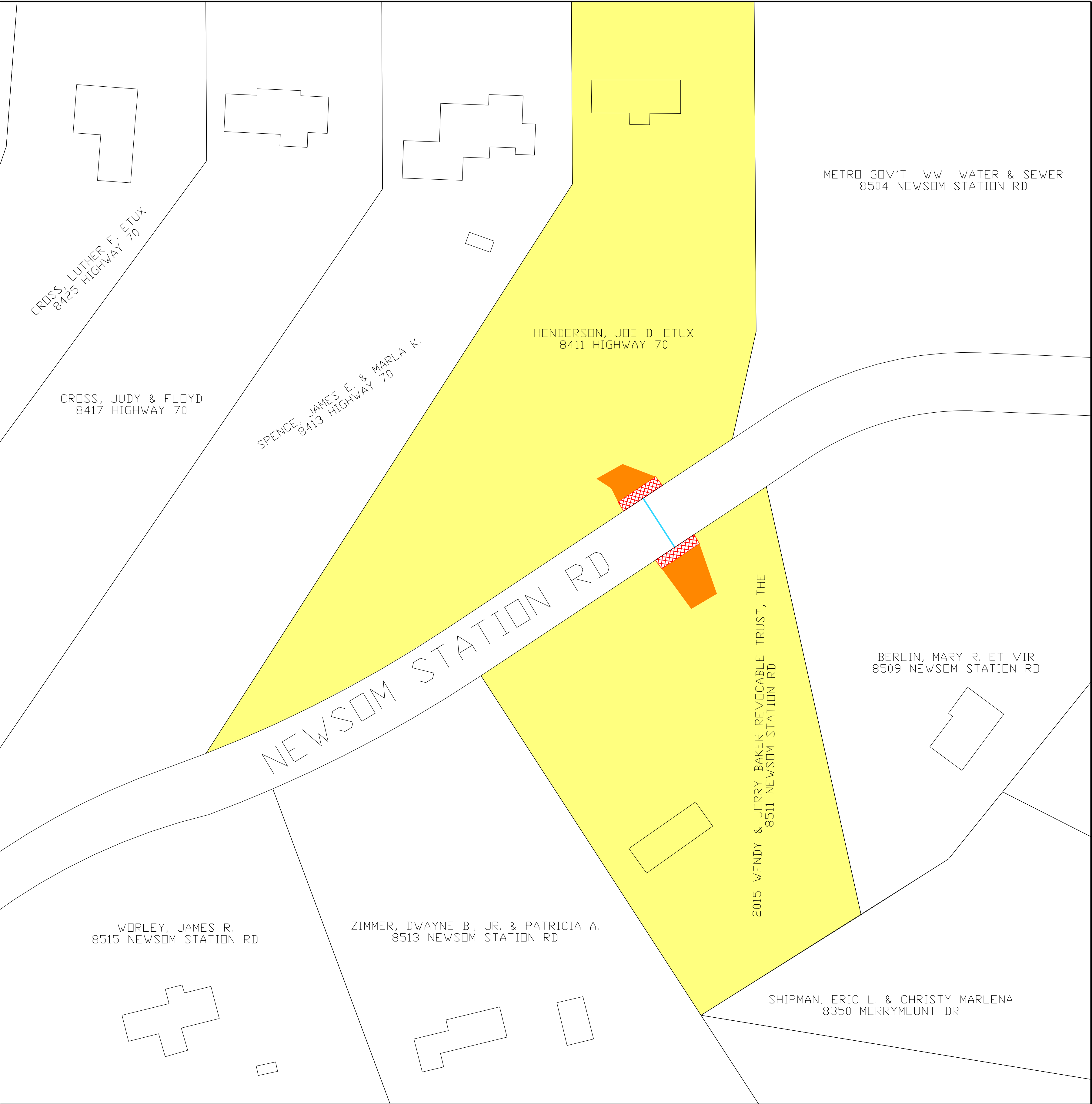
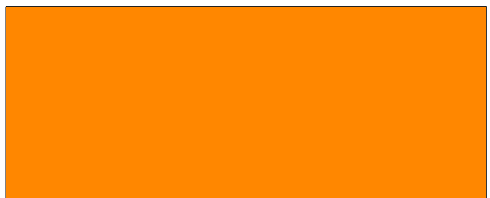


PROPOSED PERMANENT
DRAINAGE EASEMENT

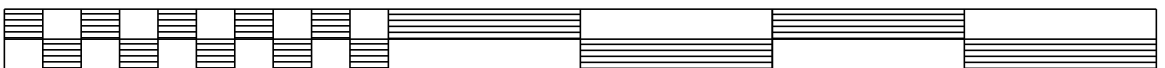


PROPOSED TEMPORARY

On behalf of the Metropolitan Planning Commission, the following item, referred to the Commission as required by the Metro Charter, has been recommended for *approval* to the Metropolitan Council:

A request for permanent and temporary easements needed to construct Project 24-SWC-109, Newsom Station Road Stormwater Improvement Project. These easements are to be acquired through negotiations and acceptance in order to complete this project.
