Dear Metropolitan Board of Parks and Recreation,

Boyle Investment Company, doing business as Capitol View, requests the Metropolitan Board of Parks and Recreation (Metro Parks) to accept an in-kind grant of a commissioned mural of art with an estimated value of \$5,000 on the existing retaining wall in the dog park area of Frankie Pierce Park (130 Josephine Holloway Ave).

This grant requires no match or other obligation for Metro Parks. No money will be sent to Metro Parks. The project will be paid for directly by Capitol View. No ongoing maintenance will be required from Metro Parks, as this is meant to be a permanent installation and will be sealed accordingly. If future touch ups are needed, Capitol View will be responsible for artist collaboration, financing any maintenance including graffiti cleanup, and will coordinate with Metro Parks.

In an effort to promote a more welcoming and engaging environment for visitors within Capitol View and Frankie Pierce Park, we are partnering with local artists to create unique experiences throughout the district. Our hope is to add a mural along the retaining wall at the back of the dog park that plays into the dog theme with bright colors and dog bones. Our team believes that people will delight in a fun opportunity to photograph their dogs and geotag the park.

We are in communication with the Metro Parks Staff on this proposed project and will continue to work with them on any further details of the project and schedule as the project moves forward. We would like to start within one month of gaining approval from the Metro Parks. We are aware that this will include time to notify the public of the dog park closure for completing the mural art project. The timeframe to complete the mural will be 4 to 5 days.

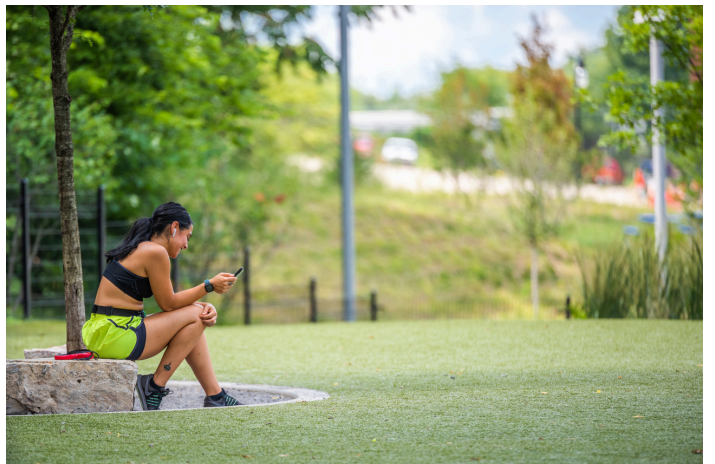

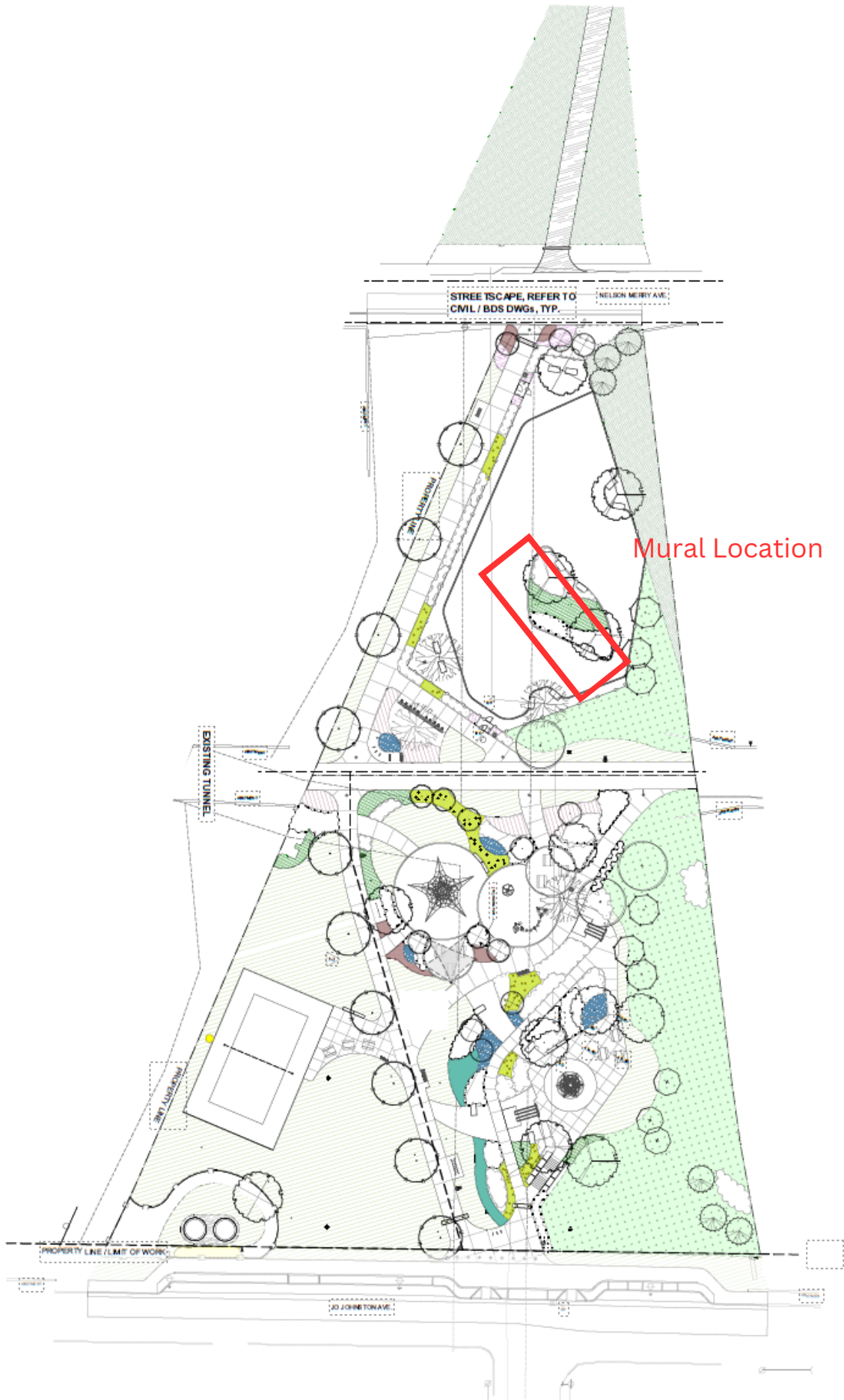


