On behalf of the Metropolitan Planning Commission, the following item, referred to the Commission as required by the Metro Charter, has been recommended for *approval* to the Metropolitan Council:

A request for the acceptance of approximately 434 linear feet of 8-inch sanitary sewer main (DIP), 859 linear feet of 8-inch sanitary sewer main (PVC), seven sanitary sewer manholes, six linear feet of 10- inch water main (DIP), 1,014 linear feet of 8-inch water main (DIP), 220 linear feet of 6-inch water main (DIP), two fire hydrant assemblies and easements to serve the Reserve at Magnolia Farms development.

The relevant Metro agencies (Metro Parks, Metro Public Works, Metro Water Services, Metro Emergency Communications, the Nashville Electric Service, Metro Finance – Public Property and the Metro Historical Commission) have reviewed the proposal and concur in the recommendation for approval. This request must be approved by the Metro Council to become effective. A sketch showing the location of the request is attached to this letter.

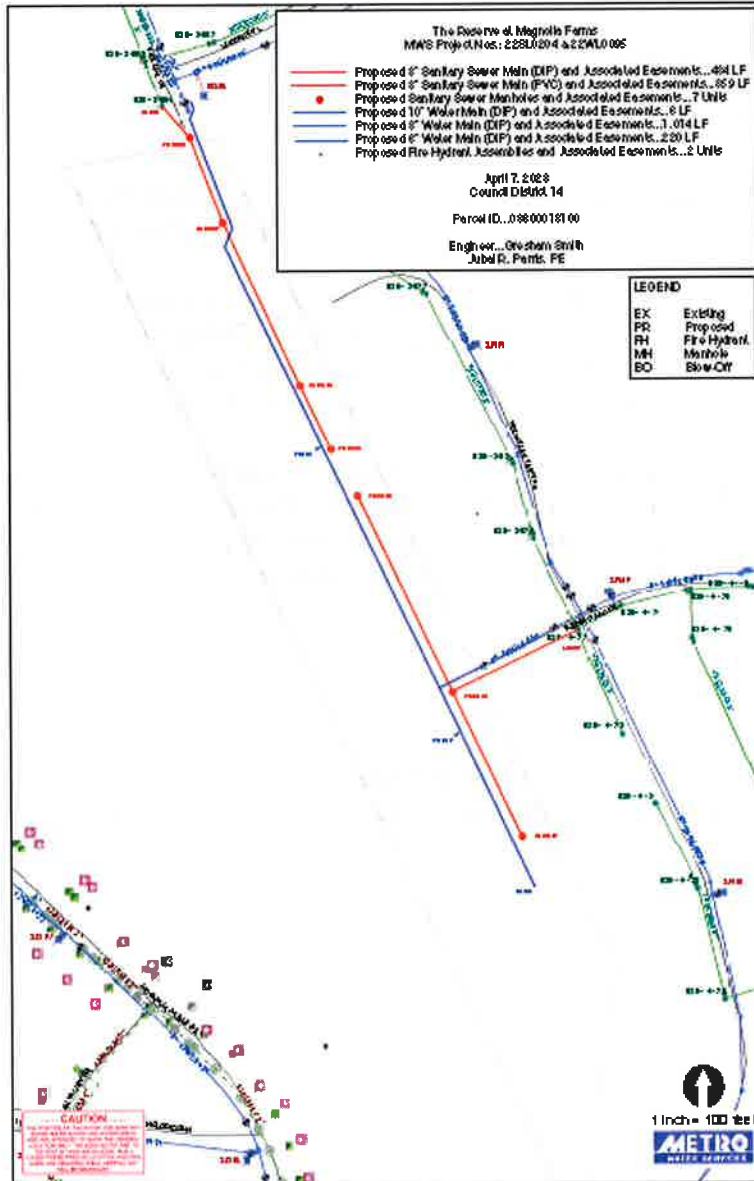

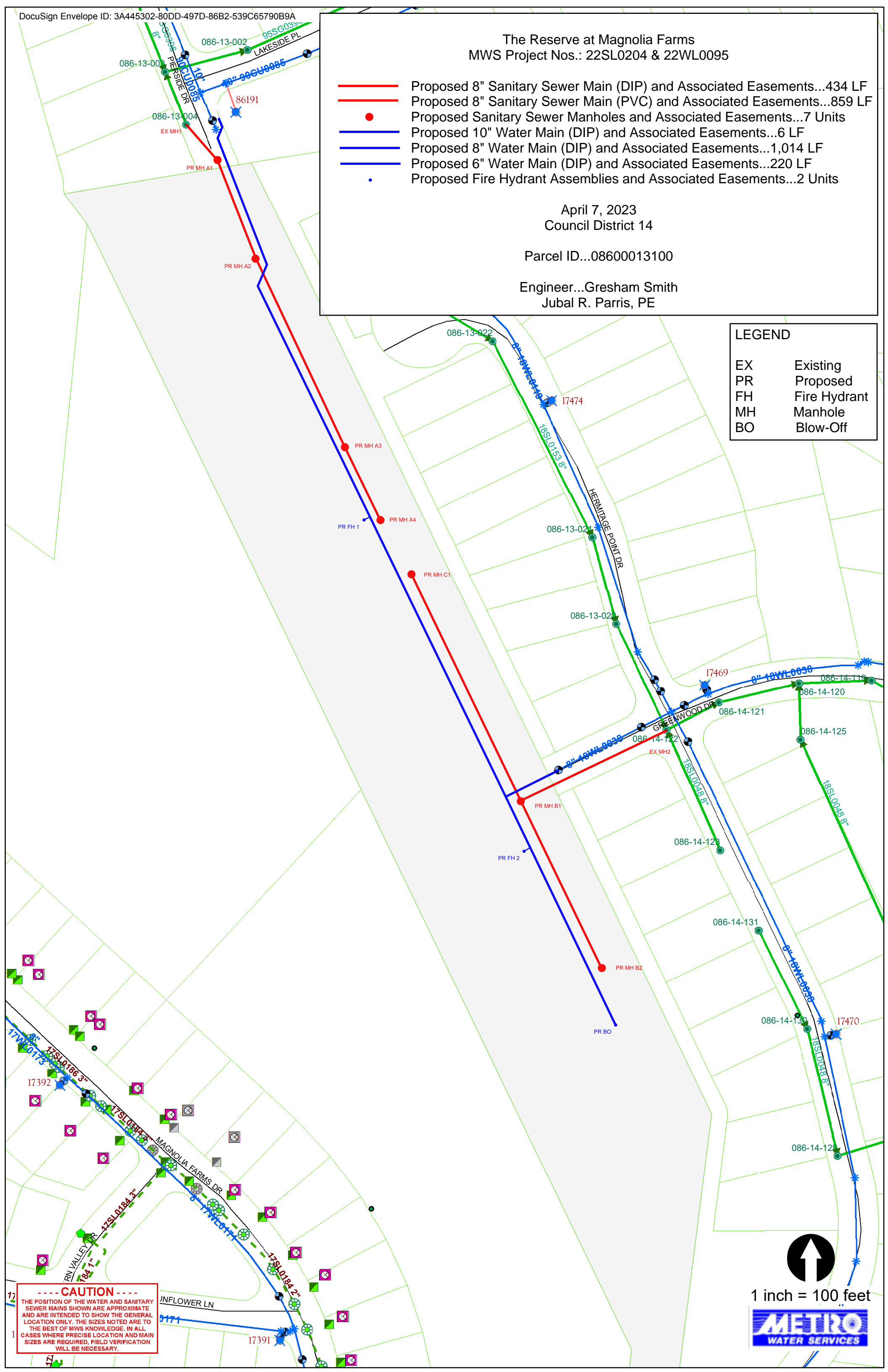
