*A request for the acceptance of approximately 1,088 linear feet of 8-inch sanitary sewer main (PVC), 424 linear feet of 8-inch sanitary sewer main (DIP), 765 linear feet of 2-inch sanitary sewer force main (PVC), 201 linear feet of 1.5 inch sanitary sewer force main (PVC), 15 sanitary sewer manholes and easements to serve the Riverview at Cumberland Hills development.*

The relevant Metro agencies (Metro Parks, Metro Public Works, Metro Water Services, Metro Emergency Communications, the Nashville Electric Service, Metro Finance – Public Property and the Metro Historical Commission) have reviewed the proposal and concur in the recommendation for approval. 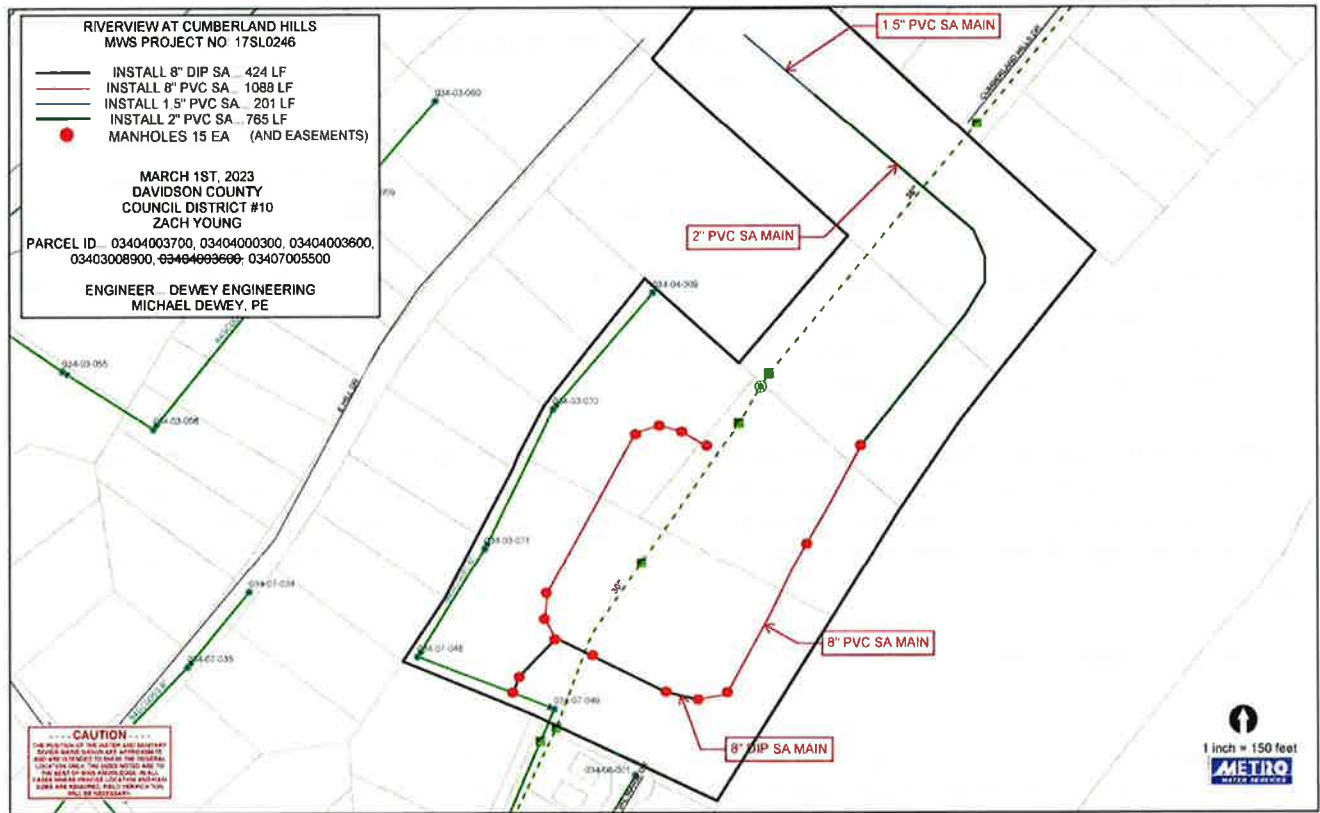

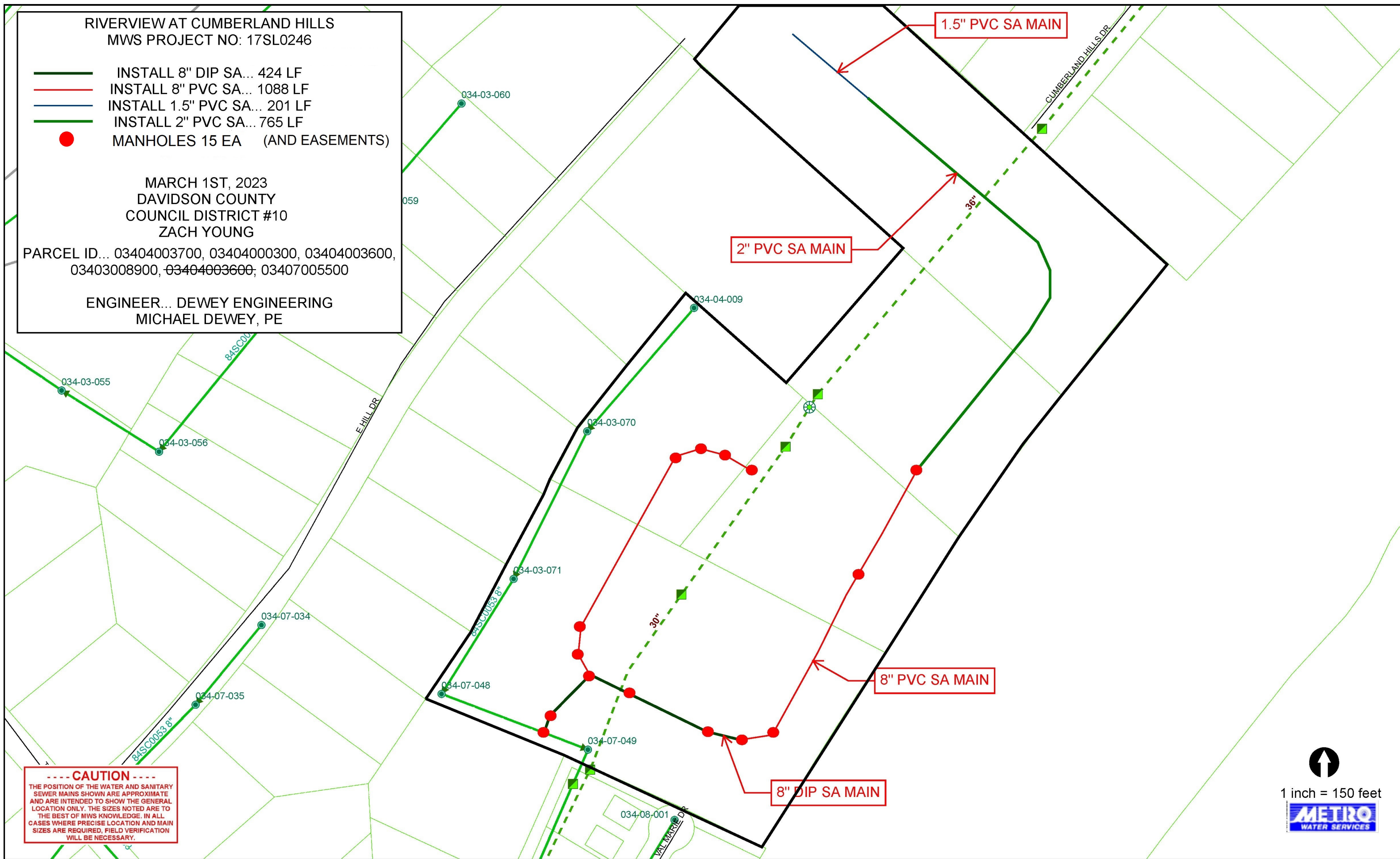
