On behalf of the Metropolitan Planning Commission, the following item, referred to the Commission as required by the Metro Charter, has been recommended for *approval* to the Metropolitan Council:

A request for the abandonment of approximately 75 linear feet of 12-inch sanitary sewer main (PVC) and one sanitary sewer manhole, and the acceptance of approximately 69 linear feet of 12-inch sanitary sewer main (DIP), 32 linear feet of 12-inch sanitary sewer main (PVC), one sanitary sewer manhole, and the rehabilitation of two sanitary sewer manholes to serve the NES Central Substation project.

The relevant Metro agencies (Metro Parks, Metro Public Works, Metro Water Services, Metro Emergency Communications, the Nashville Electric Service, Metro Finance – Public Property and the Metro Historical Commission) have reviewed the proposal and concur in the recommendation for approval. This request must be approved by the Metro Council to become effective. A sketch showing the location of the request is attached to this letter.


