RE: Request for Signs at Mill Ridge Park

The Joe C. Davis Foundation and Friends of Mill Ridge Park jointly and respectfully request your approval and acceptance of an in-kind donation valued at less than \$3,000 for the fabrication and installation of two signs - one at Mill Ridge Park and one at the Moore Farm at Mill Ridge Park - to document and recognize the contributions to Mill Ridge Park of Angela Moretti Goddard, Executive Director of the Joe C. Davis Foundation. The final design and fabrication and placement of the signs will be at the approval of the Metro Parks Department. This request will not require matching funds from the Metropolitan Board of Parks and Recreation.

It is for these reasons that we make this request:

- Angela Moretti Goddard, with exceptional imagination, determination and relationship-building skills, envisioned, identified and negotiated for the acquisition by Metro Nashville of ten separate parcels of land comprising over 600 acres to enable the creation of Mill Ridge Park.
- Ms. Goddard worked collaboratively with Parks Director Tommy Lynch and others, including Jim Fyke, to ensure that her efforts furthered the goals of the Parks Department.
- Ms. Goddard facilitated a contribution by the Joe C. Davis Foundation of more than \$4 million to Metro Nashville to assist in the acquisition of the 600+ acres.
- Ms. Goddard co-founded and fundraised for the creation of Friends of Mill Ridge Park.
- Ms. Goddard led the process to identify and recruit the Executive Director of Friends of Mill Ridge Park.
- Ms. Goddard has subsequently continued to fund, fundraise, and advocate for further developments at Mill Ridge Park, and has worked collaboratively with Director Odom to ensure continued adherence to the Parks Department's goals.
- Under Ms. Goddard's founding leadership, Friends of Mill Ridge Park, has contributed more than \$1 million to park care and advocacy and community service at Mill Ridge Park; contributed \$40,000 for the design and construction of the primitive Crossings Trailhead; and continues to create, improve, and program the primitive trails at Mill Ridge Park.

We believe that recognition of Ms. Goddard's remarkable work is extremely well-deserved, and that such recognition will encourage others in the future to work to improve Metro Parks.

Ms. Goddard is not aware that we are making this request.

In Recognition of Angela Moretti Goddard

Angela Moretti Goddard spearheaded the creation and development of Mill Ridge Park beginning in 2013.

Tasked with the simple objective of providing more green space for Southeast Nashville, Ms. Goddard, Executive Director of the Joe C. Davis Foundation, dreamed big. She built relationships with the owners of ten separate tracts of land encompassing more than 600 acres. She then developed close partnerships with the Metro Nashville Parks Department, local elected officials, key Antioch business leaders, The Conservation Fund, and others.

As a result, in 2015, Metro Government, with some financial assistance from the Davis Foundation, acquired the land and announced plans for Mill Ridge Park. Ms. Goddard then organized the creation of Friends of Mill Ridge Park and recruited its first Executive Director in 2017, to ensure the early activation and long-term care of the park. Thereafter, she became a vital part of the Friends organization as it grew and assisted in the development of the park.

Mill Ridge Park is a testament to the vision, determination, and relationship-building skills of Angela Moretti Goddard.
