For and in consideration of the sum of \$1.00, cash in hand paid and other good and valuable consideration, receipt of which is hereby acknowledged, the undersigned hereinafter referred to as Grantor, have this day granted to the Metropolitan Government of Nashville and Davidson County, acting by and through the Electric Power Board of said Government, hereinafter referred to as Grantee, a permanent utility easement for the following purposes, namely: The perpetual right to enter and to erect, maintain, repair, rebuild, operate and patrol electric power overhead and underground conductors and communications circuits with all necessary equipment reasonably incident thereto including the right to clear said easement and keep the same clear of brush, timber, inflammable structures, buildings, permanent structures, and fire hazards; all over, under, upon, and across the following described land, to wit:

UTILITY ANCHOR EASEMENT

BEING a portion of land owned by METRO GOV'T S ROSE PARK per DB.3346-PG.579 R.O.D.C. TN., located at 1025 9TH AVE S CITY OF NASHVILE, TENNESSEE identified as parcel no. 10502017100 and being more particularly described as follows:

COMMENCING at a point in the north margin of EDGEHILL AVENUE being the southwest point of curvature for a curve joining 9TH AVE S to EDGEHILL AVENUE at a 4 way intersection;

THENCE in a westerly direction along the north margin of EDGEHILL AVENUE, with a curve to the left with a radius of 602.96 feet, a central angle of 04°37'51", and a chord bearing and distance of North 85°35'37" West, 48.72 feet, an arc distance of 48.73 feet to the actual POINT OF BEGINNING;

THENCE in a westerly direction continuing with said north margin of EDGEHILL AVENUE, with a curve to the left with a radius of 602.96 feet, a central angle of 00°29'18", and a chord bearing and distance of North 88°09'12" West, 5.14 feet, an arc distance of 5.14 feet to a point for corner;

THENCE North 11°30'22" West, a distance of 24.29 feet departing from said margin to a point for corner;

THENCE North 78°29'38" East, a distance of 5.00 feet to a point for corner;


THENCE South 11°30'22" East, a distance of 25.48 feet to the POINT OF BEGINNING and containing 124 square feet or 0.0029 acres of land more or less.

To have and to hold the said easement to Grantee, its successors and assigns forever.

We covenant with the said Grantee that we are lawfully seized and possessed of said real estate, have a good and lawful right to convey the same, that the same is free of all encumbrances, except those shown of record, and that we will forever warrant and defend the title thereto against the lawful claims of all persons whomsoever.


