On behalf of the Metropolitan Planning Commission, the following item, referred to the Commission as required by the Metro Charter, has been recommended for *approval* to the Metropolitan Council:

A request for the abandonment of 560 linear feet of six-inch water main (DIP), the acceptance of 30 linear feet of six-inch water main (DIP), 498 linear feet of 12-inch water main (DIP), two fire hydrant assemblies, one sanitary sewer manhole, and easements for the Hayes Street Residential development.

The relevant Metro agencies (Metro Parks, Metro Public Works, Metro Water Services, Metro Emergency Communications, the Nashville Electric Service, Metro Finance – Public Property and the Metro Historical Commission) have reviewed the proposal and concur in the recommendation for approval. 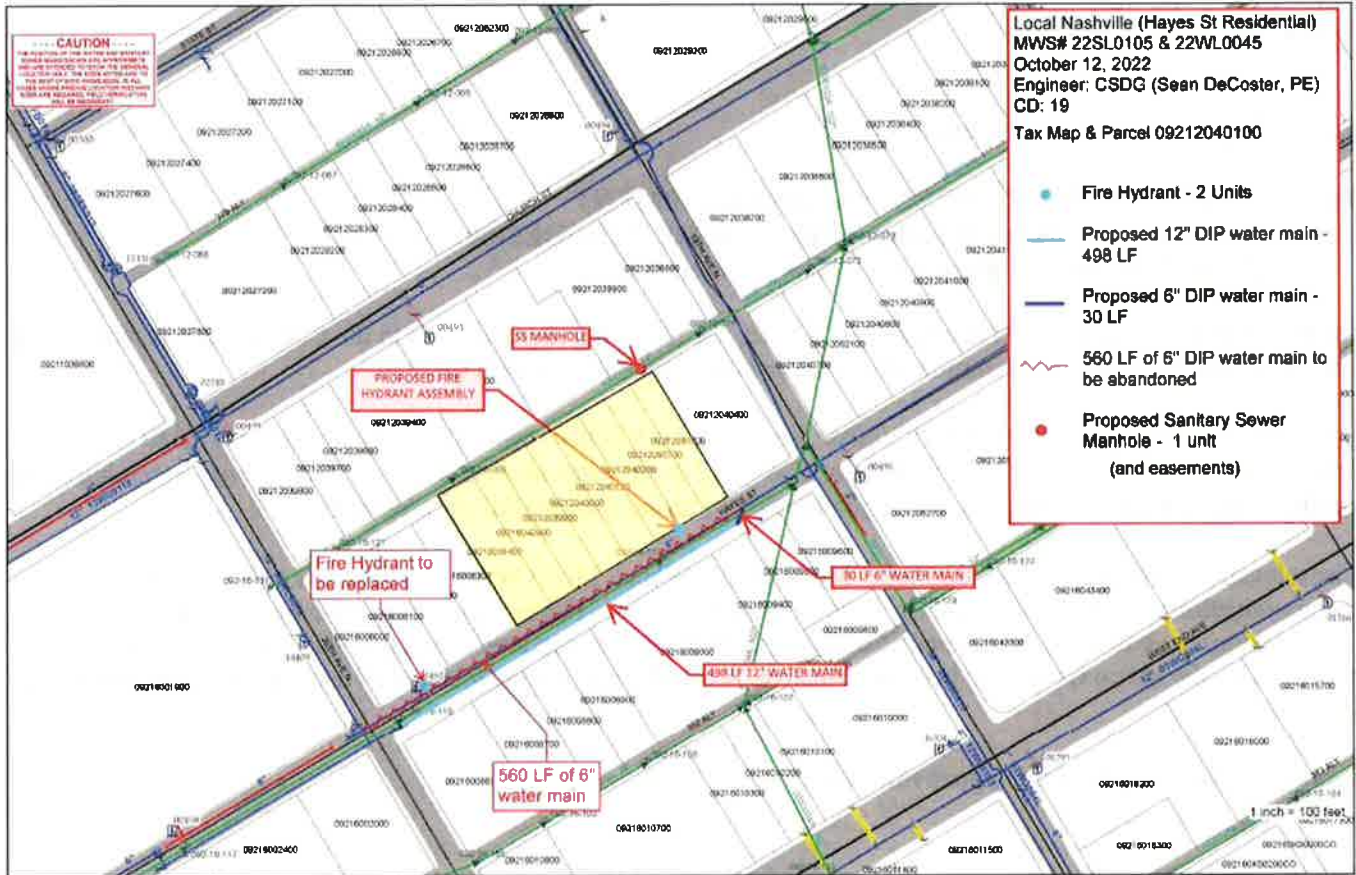

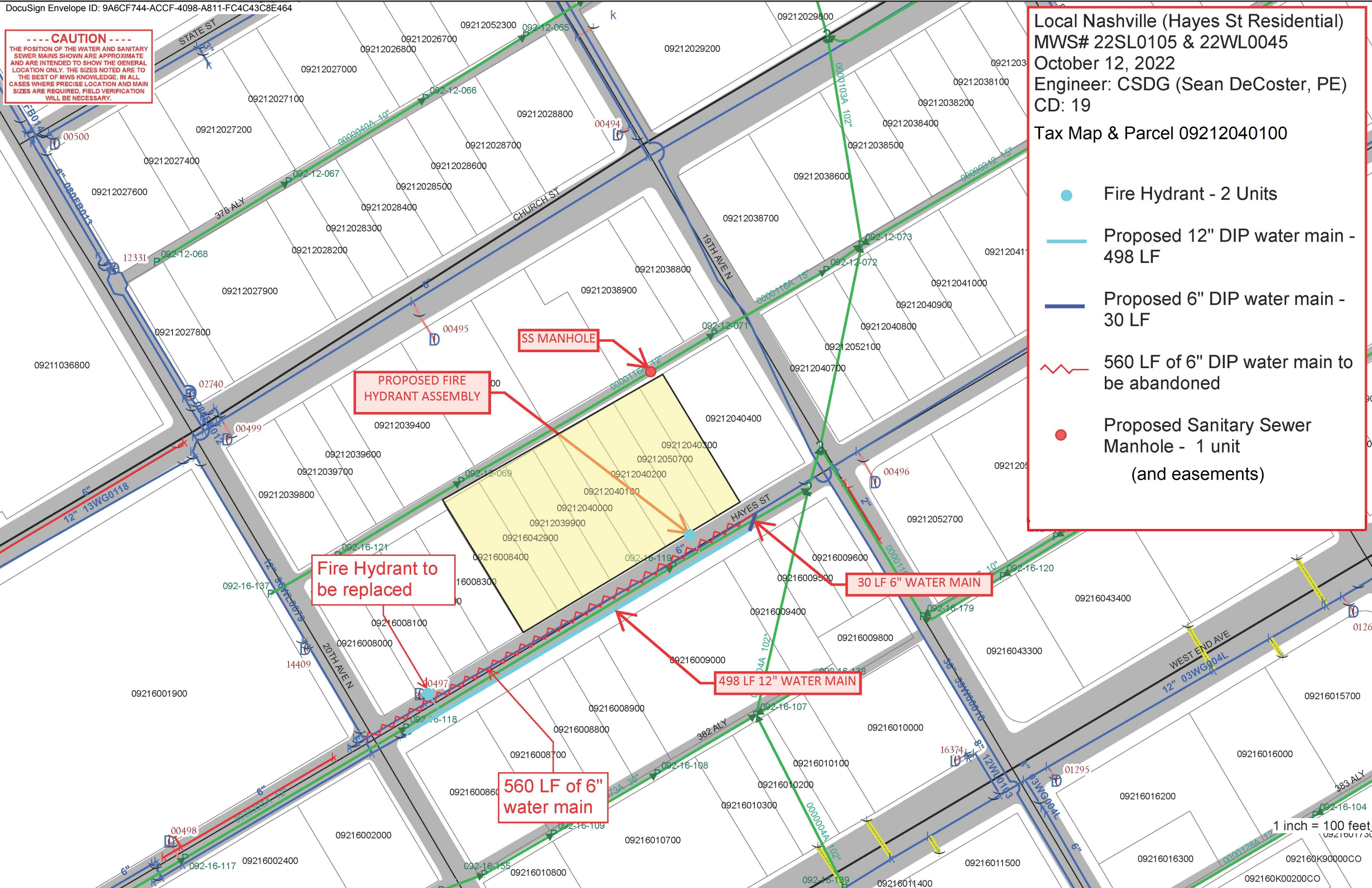
