Nashville Fire Department - CESF Local Government COVID Response

Scope of Services/Project Narrative

The Nashville Fire Department (NFD), as part of its overall mission to the citizens and the City of Nashville, focuses on providing "... high-quality fire, medical, and rescue emergency responses and community support services" ... These response and support services include providing attention and care for city and county's vulnerable populations, which include the homeless. Since the inception of the COVID-19 coronavirus, addressing the needs of the homeless within this new environment has required reassessing the strategic, tactical, and operational considerations for serving this highly vulnerable population.

The NFD's operational objective, in part, for 2020 was to support the citizens of Metropolitan Nashville and Davidson County by establishing and sustaining the multiple COVID testing sites. This can be accomplished more efficiently and timely with a van asset to be utilized for transporting support personnel, and critical COVID-19 supplies which include personal protective equipment (PPE), testing kits, and any additional needs to and from the different testing sites and to the established shelters. Vans will also be used to safely transfer COVID-19, persons waiting for results, those who are determined positive, and negative citizens to shelters for continued care and observation The NFD is also actively engaged with Nashville's Cold Patrol which assists homeless men, women, and children escape harsh winter weather by transporting them to the Nashville Rescue Mission for food, clothing, and shelter. A van would facilitate successful operations by providing safe, suitable transport which allows for COVID-19 spacing.

The homeless generate challenges of a unique nature requiring certain adjustments in Department protocols related to housing, transportation, logistics, and handling services. Transporting potential, or positive COVID-19 individuals from one location to another as needed for quarantine, ongoing assessments, minor treatment, and care, requires realignment of vehicular equipment services for operating within the medical guidelines established because of the COVID-19 coronavirus. Under the coronavirus constraints and medical precautions, the homeless population of Nashville requires unique and specific attention for addressing the challenges in providing services to this population.

To better serve the homeless population during this pandemic environment, NFD has recognized the need for establishing increased capability and capacity for providing more efficient and effective transportation and supply services on behalf of the city and counties homeless. Currently, the usage of department vehicles for homeless services is limited, requiring reassignment downtime, scheduling issues, staffing adjustments, and loss of efficiency caused by delays. Because of the inherently problematic issues associated with a lack of or limited availability of adequate and appropriate transportation many of the displaced homeless

individuals do not get timely attention and do not have an appropriate and safer means of obtaining assistance other than utilizing 911 emergency resources. The availability of the van would improve the NFD's capability in supporting Nashville's citizens who need help.

Other benefits related to COVID-19 include:

- Transport NFD personnel to designated sites for vaccination
- Transport NFD personnel to neighboring counties who request COVID-19 support
- Support the logistics with the delivery of PPE and other supplies determined to be necessary to support ongoing operations.
- A van addition would serve as a mitigation asset for response to immediate demands that do not require front-line apparatus such as a fire truck or 911 ambulance.

The purchase of a vehicle would provide the logistical and practical means for increasing capacity and more effective delivery of services addressing the specific needs of the homeless and their environment.

General Activities/Inputs

The total amount of funds requested is \$75,000.00. These funds will be used for the purchase of a van, including fuel and maintenance costs for the duration of the grant period. The van will perform a critical transportation function for transporting community residents housed in homeless shelters, rescue missions, and other sheltering facilities serving this specific vulnerable population. The van will also be utilized for transporting citizens housed in general population shelters requiring special transportation needs. The van will have multiple payload flexibility to allow for the ability to handle general sheltering supplies, medical equipment and medical supplies, and other needed items used in shelter operations. The van will significantly relieve the fire department of continued transportation and supply delivery problems brought on by the changing logistical environment as the result of the COVID-19 pandemic. The beneficial factors of the van will increase the delivery capacity and efficiency of the services and support required of these added responsibilities. The van will fill many operational challenges and gaps in the Department's COVID-19 preparedness, response, and prevention activities, and provide a mechanism for increased effectiveness in dispensing its services to the Nashville public. Specific estimates as to the number of individuals benefiting from the van's use are difficult to determine, but sheltering and homeless support activities potentially serve a staggering number of Nashvillians. It is unknown the number of people in Nashville who are without shelter.

Staff Providing Service and Assistance to Individuals

The Nashville Fire Department will staff the van's utilization with current department personnel. Depending on the van's usage, the number of personnel staffing will vary according to the specific functional need. The coronavirus pandemic has increased the need for the abovementioned services for the homeless and shelter populations. This added workload will be positively impacted by the van's usage in a much-improved method of delivery of transportation

Data Collection Procedure

Data collection for utilization of the vehicle will follow routine City of Nashville processes for accountability and use such as vehicle maintenance records, transportation logs, fuel logs, and other service records and logs addressing fleet operations. As the vehicle will be used primarily for serving the vulnerable population homeless and other sheltered residents with potential coronavirus medical needs, ancillary activities for supporting these populations will also be included in the required reporting documents. This information may include such data as the number of transports conducted, supplies delivered, and other quantitative statistical data available for analysis, in evaluating the program goals in demonstrating the positive impact of the vehicle purchase in the Department's preparation, prevention, and response to COVID-19.

Outcomes

If awarded funds under this grant, the Nashville Fire Department will submit a narrative report as required by the grant guidelines, outlining the justification for the vehicle's purchase and how this expenditure has contributed to the Department's mission in preparation, prevention, and response needs to the COVID-19 outbreak. In addition, the department will provide a tracking summary of the vehicle's purchase documentation.

Collaborative Activities

As a full-service public safety organization, the Nashville Fire Department maintains a continued collaborative relationship with a host of similar public safety agencies, service organizations, private corporations, medical organizations, social service agencies, and other providers and suppliers in coordinating and operating within the COVID-19 environment. These relationships are at the core of the Department's mission, and it is fully committed and dedicated to maintaining and strengthening those collaborations as it provides its services to the City of Nashville, and its citizens. The Department will continue conducting its work by attendance at public safety organizational meetings, area strategy and planning sessions, continued coordination of emergency services, interaction with various social services and organizations dedicated to serving the city's vulnerable populations and providing direct services and support to all area agencies using this grant purchased vehicle. Collaboration of services among many of the agencies and organizations mentioned will benefit through the added availability of transportation use in transporting individuals in need of a host of services, the ability to have additional support for delivery of supplies and equipment and knowing that additional transportation resources are available during emergencies and when unplanned supply and logistical problems arise.


