Creative Parks Nashville requests the Metro Nashville Board of Parks and Recreation to accept an in-kind grant of equipment valued at \$28,638.47 for support and expansion of the Metro Parks Music, Theater and Visual Arts programs.

- \$6,090 for a pottery glaze storage table. This equipment will allow Metro Parks Visual Arts to improve the safety and access of our glaze chemical storage under the Parks Patrol building in Centennial Park.
- \$4,978 for two storage sheds at Centennial Art Center to replace the existing damaged shed and an additional shed to provide for additional pottery storage.
- \$8,070.47 for a portable dance floor to be used during Metro Parks Music Big Band Dances, Celebrate Nashville Cultural Festival and other Metro Parks and Creative Parks Nashville events. This will provide a temporary dance floor while the new Centennial Event Shelter is under construction.
- \$9,500 for upgrading Looby Theater lights to LED lights. Metro Parks has improved safety in the Looby Theater recently and these lights will be energy efficient and have a much longer lifespan.

The equipment may be used for whatever purpose that Metro Parks and Recreation needs. No money will be sent to Metro Parks or Metro Government. The grant requires no other obligation from Parks or Metro Government.
