On behalf of the Metropolitan Planning Commission, the following item, referred to the Commission as required by the Metro Charter, has been recommended for *approval* to the Metropolitan Council:

A request for the relocation of one fire hydrant assembly, the abandonment of approximately 115 linear feet of 12-inch and 8-inch sanitary sewer mains and one sanitary sewer manhole, and the acceptance of 115 linear feet of 12-inch sanitary sewer mains (DIP) and two sanitary sewer manholes to serve the Metro Permanent Supportive Housing development.

The relevant Metro agencies (Metro Parks, Metro Public Works, Metro Water Services, Metro Emergency Communications, the Nashville Electric Service, Metro Finance – Public Property and the Metro Historical Commission) have reviewed the proposal and concur in the recommendation for approval. This request must be approved by the Metro Council to become effective. A sketch showing the location of the request is attached to this letter.

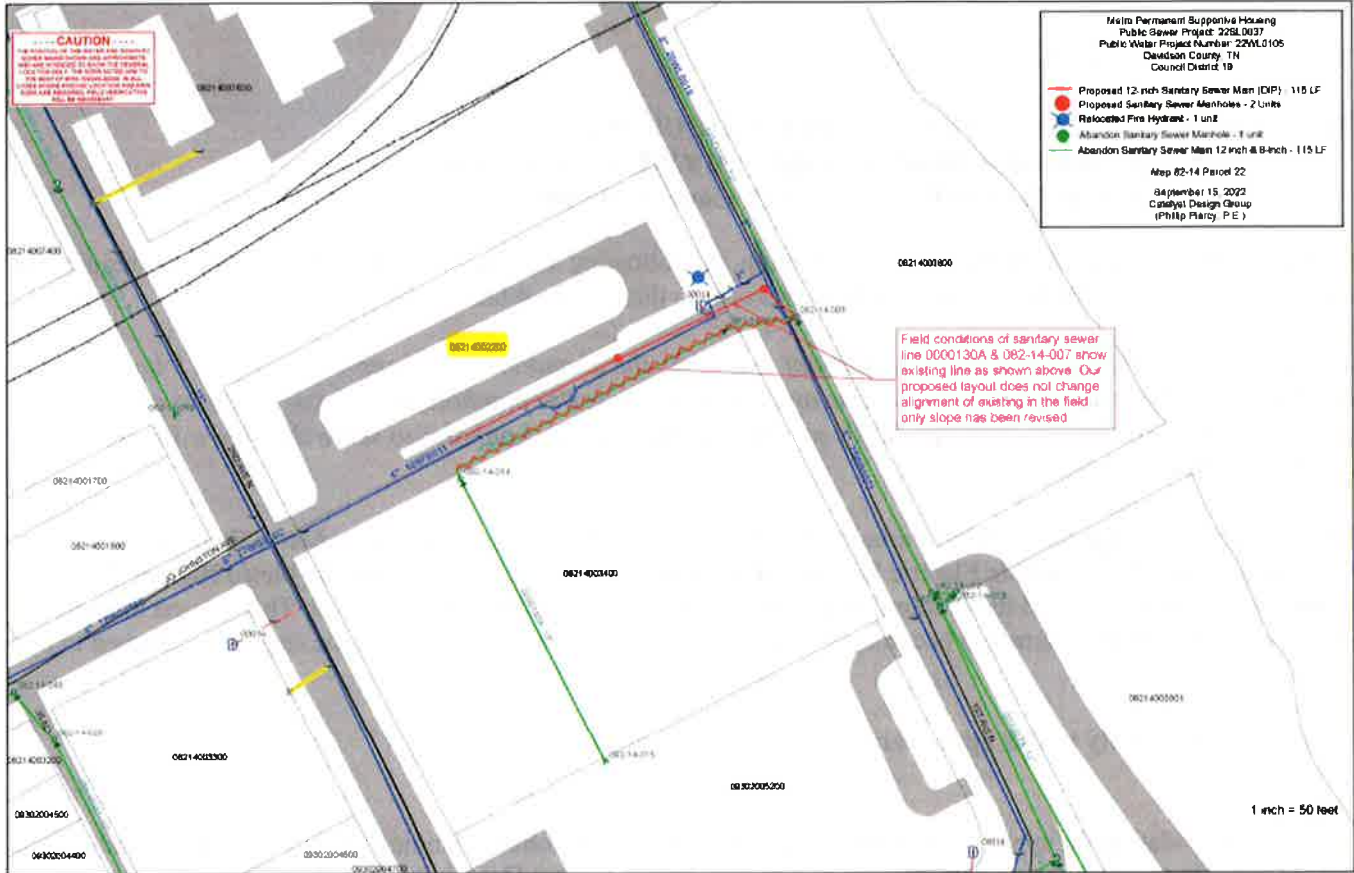

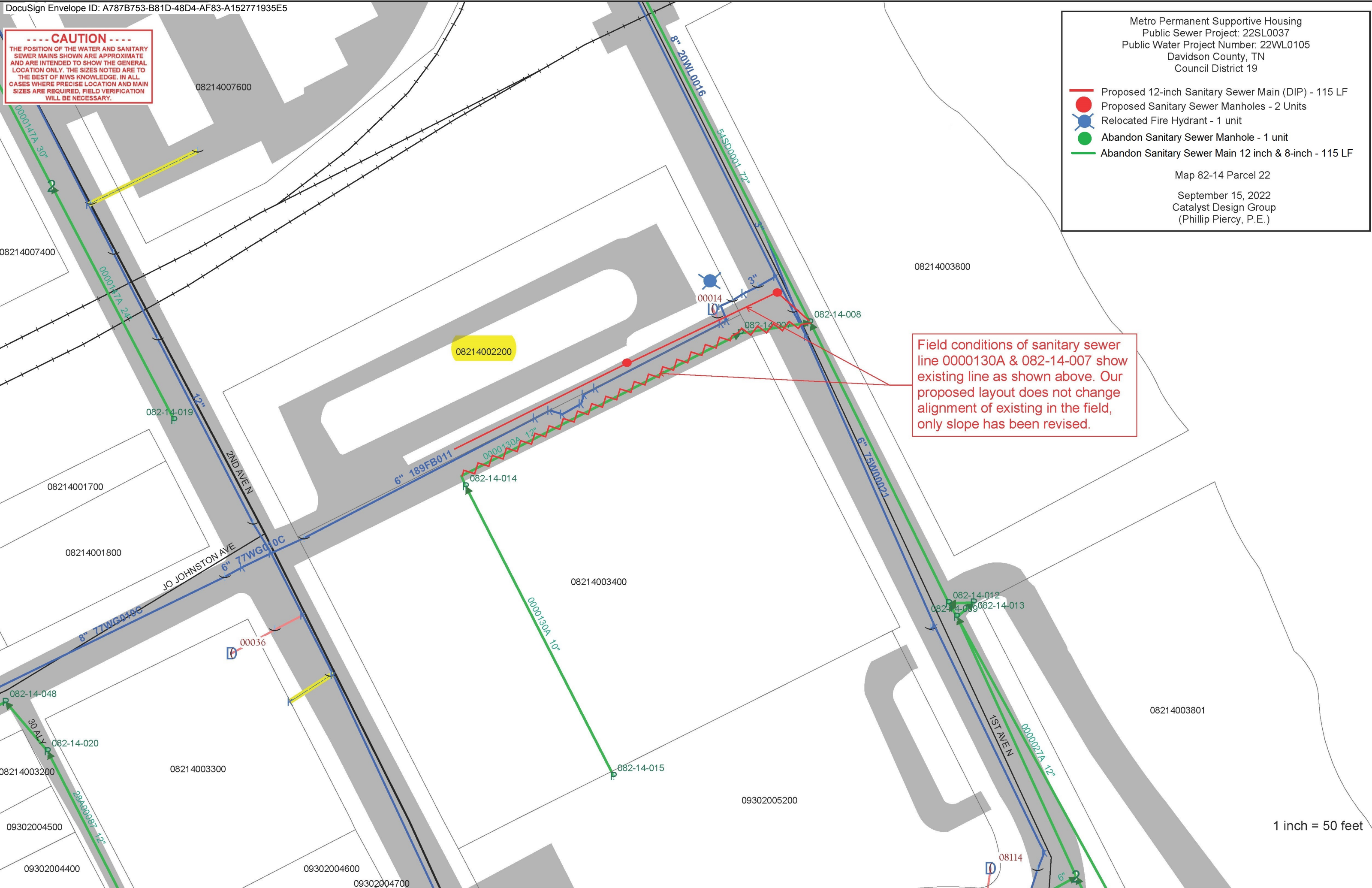
