On behalf of the Metropolitan Planning Commission, the following item, referred to the Commission as required by the Metro Charter, has been recommended for *approval* to the Metropolitan Council:

*A request for the acceptance of approximately 963 linear feet of six-inch water main (DIP), 420 linear feet of eight-inch water main (DIP), five fire hydrant assemblies and approximately 464 linear feet of eight-inch sanitary sewer main (DIP), 835 linear feet of eight-inch sanitary sewer main (PVC), 357 linear feet of two-inch sanitary sewer force main (PVC), 9 sanitary sewer manholes and any associated easements to serve the Parks at Cane Ridge – Phase 1C development.*

The relevant Metro agencies (Metro Parks, Nashville Department of Transportation, Metro Water Services, Metro Emergency Communications, the Nashville Electric Service, Metro Finance – Public Property and the Metro Historical Commission) have reviewed the proposal and concur in the recommendation for approval. This request must be approved by the Metro Council to become effective. A sketch showing the location of the request is attached to this letter.




