Testing/Go Live Support:

Professional Services and Development resources will be made available to address issues that arise from testing in train and support go live in production.

Assumptions:

- The Belle Meade storm application/account will be created from the sewer application/account, and inherit the same flags as sewer for tax code, tax type, penalty code, cycle, route, etc.
- There are only 2 Belle Meade storm sales classes for item billing: Residential and Non Residential
- Belle Meade Storm rates will use the same proration logic as Metro storm rates
- Belle Meade Storm will not require separate General Ledger numbers
- There will not be a GIS interface used to keep the lot size/billable sq feet up to date and will be done manually
- Belle Meade storm collections process will be the same as Metro's collections process and Belle Meade accounts do not need to be exempt
- No new work orders are needed
- No new permit criteria is required for Belle Meade Storm
- No Misc charges are required for Belle Meade Storm
- No Bill print changes are required by S&S and any changes will be handed by the bill print vendor
- No changes to payment priority are required

Out of Scope:

- Development changes not related to conversion of new storm accounts
- Additional General Ledger set up
