On behalf of the Metropolitan Planning Commission, the following item, referred to the Commission as required by the Metro Charter, has been recommended for *approval* to the Metropolitan Council:

A request for the abandonment of approximately 359 linear feet of 30-inch combination sanitary sewer main (brick), 272 linear feet of 8-inch sanitary sewer main (PVC), three sanitary sewer manholes, and the acceptance of approximately 276 linear feet of 8-inch sanitary sewer main (PVC) and five sanitary sewer manholes to serve the Society Nashville development.

The relevant Metro agencies (Metro Parks, Metro Public Works, Metro Water Services, Metro Emergency Communications, the Nashville Electric Service, Metro Finance – Public Property and the Metro Historical Commission) have reviewed the proposal and concur in the recommendation for approval. This request must be approved by the Metro Council to become effective. A sketch showing the location of the request is attached to this letter.

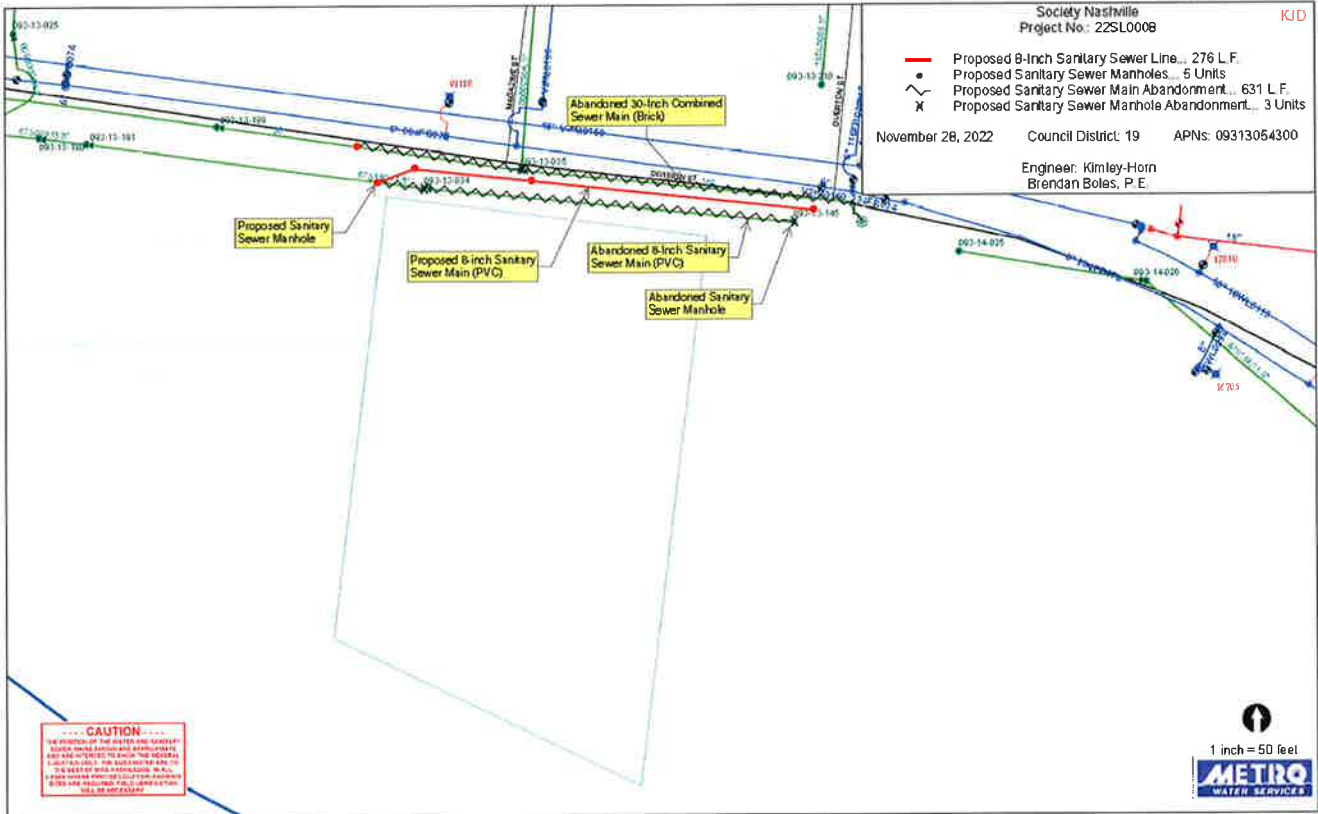

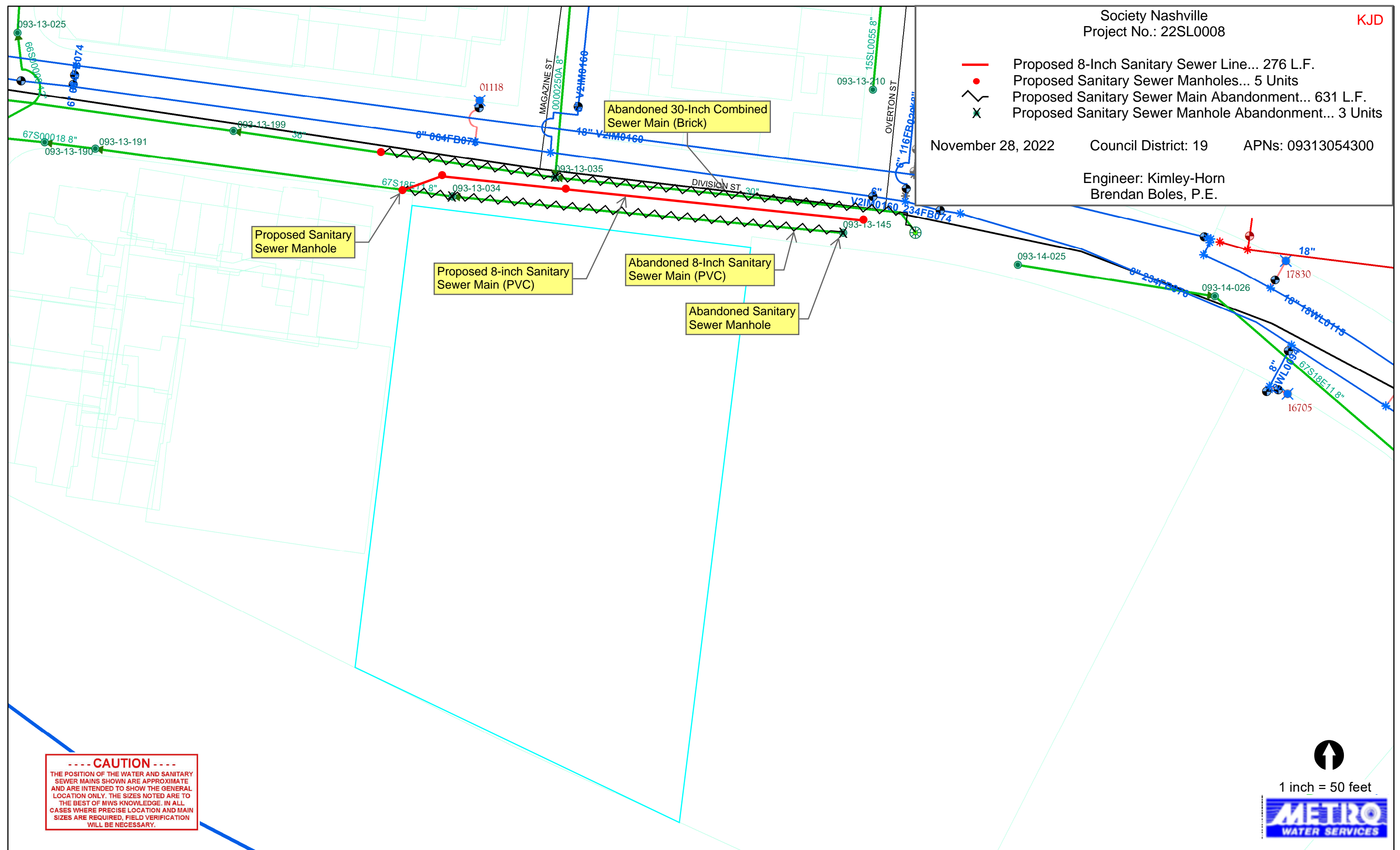
