FINAL ORDER CLOSING ESTATE WITHOUT DETAILED ACCOUNTING

This matter is before the Court upon the sworn statement of the Executor, JUDD MITCHELL, the Distributee Statements of the beneficiaries, and the Release issued by the Tennessee Bureau of TennCare.

Based on the examination of said documents, the Court finds as follows:

1. JUDD MITCHELL is the Executor of this Estate duly appointed by the Court.
2. The Estate is solvent.
3. The Estate has been fully administered.
4. All claims and debts of the Estate have been paid, including taxes due to the United States Treasury.
5. Decedent was not enrolled in the TennCare program at the time of her death, nor did she receive any TennCare program benefits. A Release from the Tennessee Bureau of TennCare has been properly filed with the Court.
6. The Executor of the Estate has stated in his Affidavit that all claims have been paid and that the Estate has been fully administered.
7. The beneficiaries of the Estate have confirmed their satisfaction regarding the performance of the Executor, have waived the right to an inventory or detailed

final accounting of the Estate, have approved the fees of the attorneys for the Estate, have acknowledged receipt of proper distribution from the Executor, and have released the Executor of any further liability in connection with the Estate.

The Court therefore finds that the Estate has been fully and completely administered and it is accordingly ORDERED, ADJUDGED AND DECREED that this estate is closed without a detailed accounting and the Executor is hereby discharged of his duties.
