On behalf of the Metropolitan Planning Commission, the following item, referred to the Commission as required by the Metro Charter, has been recommended for *approval* to the Metropolitan Council:

A request for the abandonment of approximately 191 linear feet of 8-inch sanitary sewer main (PVC), 40 linear feet of 15-inch sanitary sewer main (PVC) and easements, and the acceptance of approximately 1,262 linear feet of 8-inch water main (DIP), 517 linear feet of 8-inch sanitary sewer main (PVC), three fire hydrant assemblies, two sanitary sewer manholes, and easements to serve the Oliveri Phase 1 development.

The relevant Metro agencies (Metro Parks, Metro Public Works, Metro Water Services, Metro Emergency Communications, the Nashville Electric Service, Metro Finance – Public Property and the Metro Historical Commission) have reviewed the proposal and concur in the recommendation for approval. This request must be approved by the Metro Council to become effective. A sketch showing the location of the request is attached to this letter.

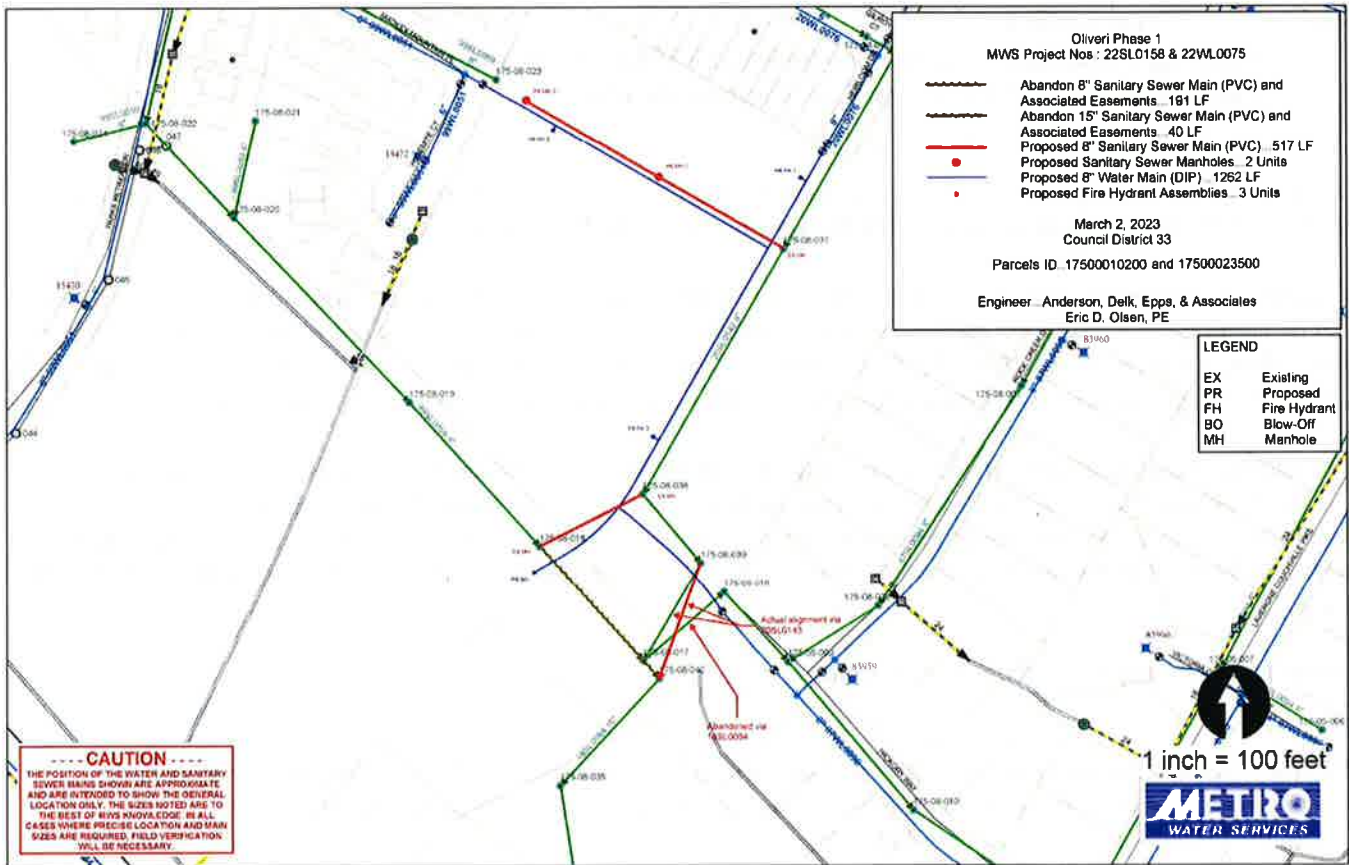

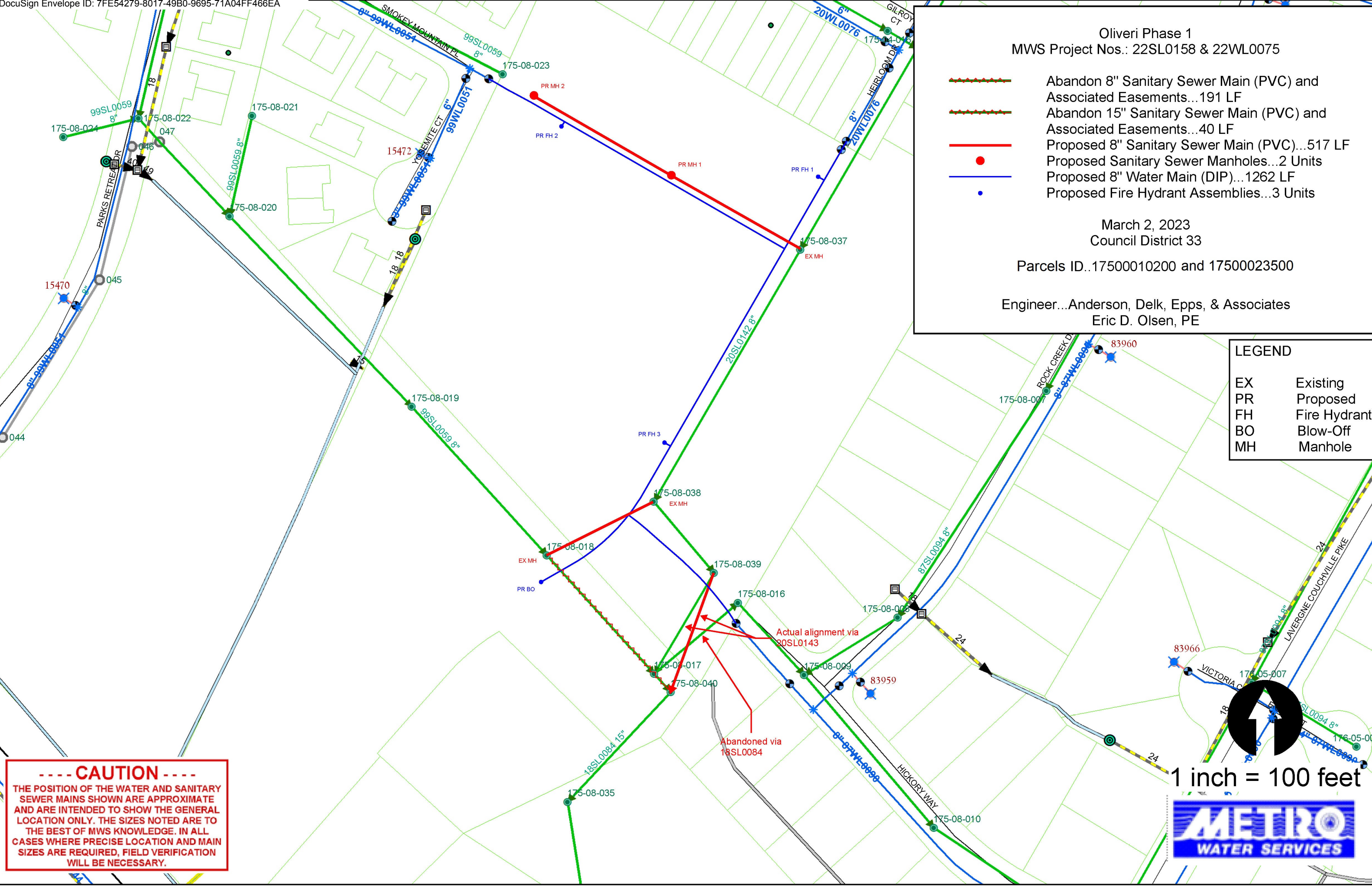
