

FIRST AMENDMENT TO SEWAGE TREATMENT AGREEMENT BETWEEN THE  
METROPOLITAN GOVERNMENT AND THE CITY OF BELLE MEADE

WHEREAS, as approved by RS2024-724, the Metropolitan Government of Nashville and Davidson County (“Metro”) and the City of Belle Meade (“Customer”) entered into an agreement (the “Agreement”) dated September 17, 2024, and effective October 1, 2024, relating to the transportation and treatment of sewage flows from Customer’s System; and

WHEREAS, the parties desire to amend the Agreement as set forth herein to permit Metro to bill and collect Customer’s residential and commercial Stormwater User Fee at Customer’s expense.

Now, therefore, the parties agree as follows:

1. Except as specifically modified herein, all of the terms of the Agreement shall remain in full force and effect.
2. This Amendment shall become effective only upon its approval by the City of Belle Meade Board of Commissioners and the Metropolitan Council and filing with the Metropolitan Clerk.
3. Paragraph 3 of the Agreement, entitled “Billing,” is amended to read as follows:

3. Billing.

- A. The parties agree that Metro will read the water meters for Customer’s water and sewerage customers and, based on the meter readings obtained, bill such customers for:
  - 1) water service at the applicable rates set forth in the Metropolitan Code of Laws; plus
  - 2) sewerage service at the Utility Price established in this Agreement; plus
  - 3) a surcharge of 10% of the amount due for sewer service as provided in BL2010-790; plus
  - 4) an administrative fee of 10% of the charges due for wholesale sewerage service at the Utility Price; plus
  - 5) a surcharge (“Belle Meade Surcharge”) as directed by Customer.
- B. The parties agree that Metro will bill and collect residential and commercial property Stormwater User Fee’s on Customer’s behalf and at Customer’s established rates.
  1. Customer will pay for all CIS changes requiring assistance from the software provider; plus
  2. Customer will pay Metro an administrative fee of 10% of the Stormwater Fee;
  3. Metro will remit payment, minus administrative fees to Customer on a monthly basis.

4. All other terms and conditions of the Agreement shall remain unchanged.






