On behalf of the Metropolitan Planning Commission, the following item, referred to the Commission as required by the Metro Charter, has been recommended for *approval* to the Metropolitan Council:

A request to amend Council BL2023-126 and Proposal No. 2023M-163ES-001 for the purpose of accepting an additional 30 linear feet of 6-inch water main (DIP) and the vertical relocation and raising of approximately 32 linear feet of existing 12-inch water main. Specific infrastructure instead now will be acceptance of approximately 55 linear feet of 6-inch water main (DIP), one fire hydrant assembly, 159 linear feet of 8-inch sanitary sewer main (DIP), two sanitary sewer manholes, the vertical relocation (raising) of approximately 32 linear feet of existing 12-inch water main and any associated easements to serve the Edwin Greens - Phase 2 Revision 1 development.

The relevant Metro agencies (Metro Parks, Metro Public Works, Metro Water Services, Metro Emergency Communications, the Nashville Electric Service, Metro Finance – Public Property and the Metro Historical Commission) have reviewed the proposal and concur in the recommendation for approval. This request must be approved by the Metro Council to become effective. A sketch showing the location of the request is attached to this letter.




