

AMENDMENT TO LICENSE AGREEMENT FOR THE USE OF 'BORDEAUX HOSPITAL'

THIS AMENDED LICENSE AGREEMENT is between the Department of Defense (DoD), acting as a representative for the United States Government (the "LICENSEE"), and CITY OF NASHVILLE ("LICENSOR").

It is mutually agreed by and between LICENSEE and LICENSOR, that the LICENSE AGREEMENT (DACA31-3-2023-0669, RMT-NAV-SEPTEMBER-NASHVILLE-001) for the use of 'Bordeaux Hospital', is hereby amended as follows:

- I. Section 10 of the LICENSE AGREEMENT is deleted in its entirety and replaced with the following:

10. REVOCABILITY. This License is revocable by either party, at any time, with reasonable attempts made to inform the other party before preparations for the next training evolution have begun. Otherwise, this License will remain in force and effect from '07 September to 12 September 2023'.

- II. All other terms and conditions of the LICENSE AGREEMENT not expressly amended herein shall remain in full force and effect.
