

Failure to provide this information will deem your application *incomplete* and postpone your application's consideration by the Metropolitan Planning Commission.

The Fairgrounds Nashville's Coliseum was built in 1925 and burned down in 1970. It was a premier Nashville entertainment venue that hosted the circus, rodeos, telethons, consumer shows, sporting events, and concerts including Frankie Avalon, Jerry Lee Lewis, Hank Williams, Jr., and Janis Joplin (Tennessean).
