



Betty Turney-Turner, owner/Artist at this Little Light Glass Art, has been a a glass artist for over 20 years. Betty has traveled extensively throughout the world to study with Master glass teachers, craftsman, and artisans to advance her knowledge and skill in glass art. She has taught stained glass and fused glass classes at Volunteer State Community College and at numerous Metro Nashville public schools. Betty has shown her art in many local art shows and has been featured in magazines and televise shows. She was also a featured artist in the Tennessee Woman of Glass gallery show at the Customs House Museum.

Betty opened her glass studio in 2015, where she works today creating her glass art, and teaching classes for all skill levels. Betty is one of only three glass shop owners in the U.S. This Little Light Studio has played host of internationally renowned glass masters from the US and abroad, and offers community engagement days open to anyone wishing to explore glass art for themselves.

Finally, Betty is also the creator of The Glass Freedom Project, which brings fused glass arts to afterschool local youth programs.


As part of its *Art of Healing Exposition*, the Vanderbilt Curb Center for Art, Enterprise & Public Policy commissioned Betty and her team of artists* to create an interactive sculpture designed to promote healing as part of the 2021 'Black on Buchanan' Juneteenth Celebration.

Pathway to a Higher Note depicts a young boy and girl who are standing on a base made from a quilt, which features the Underground Railroad quilt designs representing freedom and safety. Both children are hold a heart between them. The heart, a representation of love, has the North Star at its center. Each child holds a musical note in their hand, a nod to the importance of music to Black culture as a healing balm, a celebration and a staple of religious practices. The children's clothing features Adinkra Symbols made from kiln-cast glass and mosaic tile to acknowledge their African heritage..

To remember and celebrate Emancipation, community participants were invited to select a tile of their choosing, and write the name of loved one they wished to honor and thank, before affixing the piece to the sculpture in a place of their choosing. In this way, the artists hoped to the public could recognize any of their ancestors who were the victims of enslavement, allowing allow each individual to create a living tribute to those who came before and paving the way for a brighter future for the coming generations.

'Pathway' was envisioned and executed by Betty Turney-Turner, Beth Herrig Volz, Martha Morales-Purucker and Alfred Turney III)


