It is mutually agreed by and between Metro and Recipient, that Grant Contract #L-6046 is hereby amended as follows:

- I. Amend Section B.1. Grant Contract Term to extend the contract term to June 30, 2026. The amended clause will read as follows:
 - "Grant Contract Term. The term of this Grant will begin on the effective date and end on June 30, 2026, or when funds are depleted, whichever occurs first. Metro will have no obligation for services rendered by the Recipient that are not performed within this term."
- II. Effective Date. This Grant Contract amendment shall not be binding upon the parties until it has been signed by the Recipient and then by authorized representatives of the Metropolitan Government and approved by the Metropolitan Council and filed in the office of the Metropolitan Clerk. The revisions set forth herein shall become effective once the Grant Contract Amendment has been so signed and filed. All other terms and conditions of the Grant Contract not expressly amended herein shall remain in full force and effect.
