I hereby move to amend Substitute Ordinance No. BL2023-101 by amending Section 4 to add the following condition:

9. The maximum building height shall be 2 stories in 35' in height as measured from the finished grade.

SUBSTITUTE ORDINANCE NO. BL2023-133

An ordinance to amend Title 17 of the Metropolitan Code of Laws, the Zoning Ordinance of The Metropolitan Government of Nashville and Davidson County, by changing from CS and AR2A to ~~MUL~~ CS zoning for property located at 3332 Murfreesboro Pike, north of the intersection of Murfreesboro Pike and Mt. View Road. (4.86 acres), and located within the Murfreesboro Pike Urban Design Overlay, all of which is described herein (Proposal No. 2024Z-004-001).

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. That Title 17 of the Code of Laws of The Metropolitan Government of Nashville and Davidson County, is hereby amended by changing the Official Zoning Map for Metropolitan Nashville and Davidson County, which is made a part of Title 17 by reference, as follows:

By changing from CS and AR2A to ~~MUL~~ CS zoning for property located at 3332 Murfreesboro Pike, north of the intersection of Murfreesboro Pike and Mt. View Road. (4.86 acres), and located within the Murfreesboro Pike Urban Design Overlay, being Property Parcel No. 045 as designated on Map 164 of the Official Property Identification Maps of The Metropolitan Government of Nashville and Davidson County, all of which is described by lines, words, and figures on the attached sketch, which is attached to and made a part of this ordinance as though copied herein.

Section 2. Be it further enacted, that the Metropolitan Clerk is hereby authorized and directed, upon the enactment and approval of this ordinance, to cause the change to be made on Map 164 of said Official Zoning Map for Metropolitan Nashville and Davidson County, as set out in Section 1 of this ordinance, and to make notation thereon of reference to the date of passage and approval of this amendatory ordinance.

Section 3. The Metropolitan Clerk is directed to publish a notice announcing such change in a newspaper of general circulation within five days following final passage.

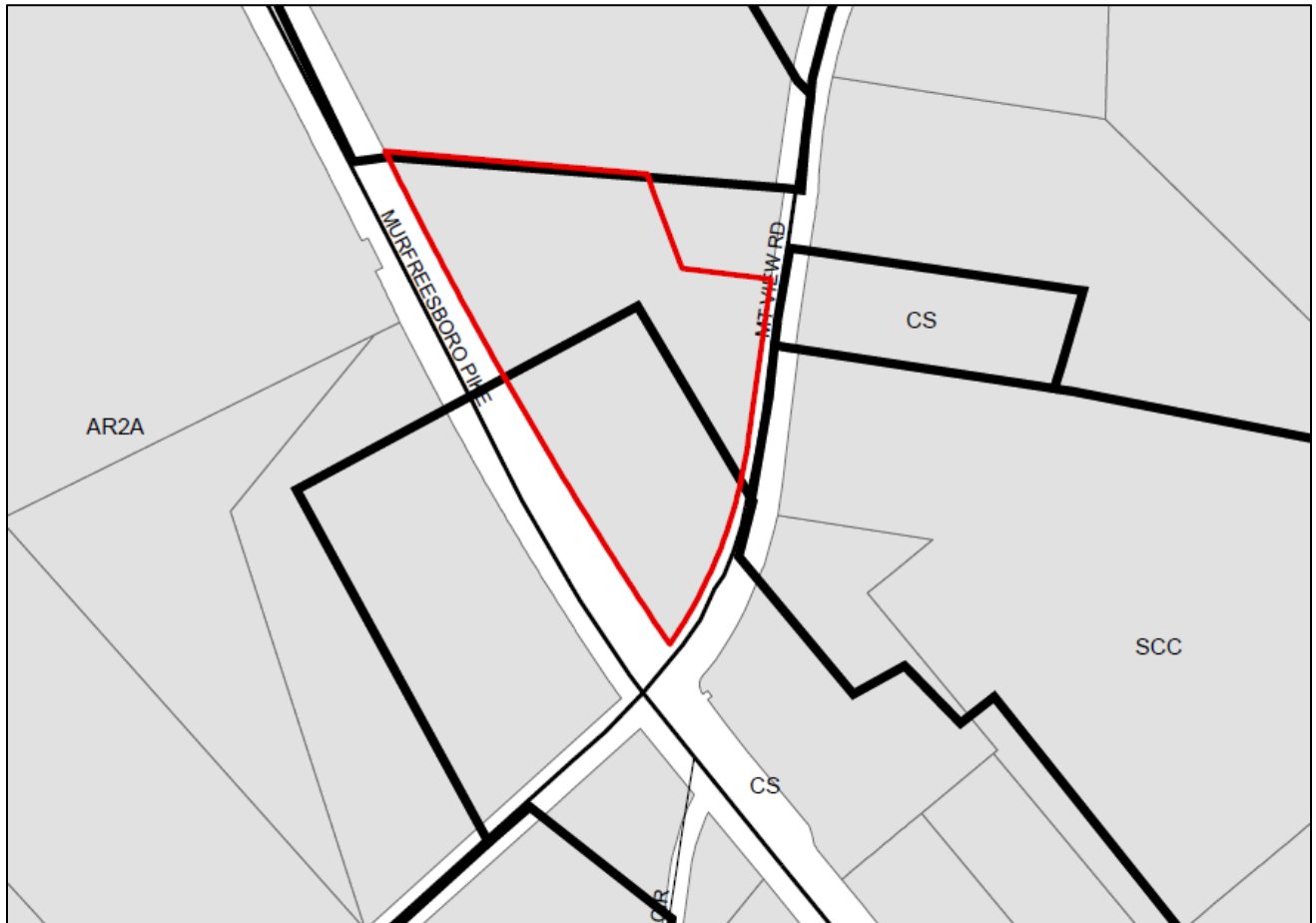

ORDINANCE NO. BL2023-70

Madam President –

I hereby move to amend Ordinance No. BL2023-70 by amending Section 1 as follows:

A. No person shall stop, stand or park any wagon, pushcart, platform, table, automobile, truck or other vehicle, or erect any temporary stands, signs or otherwise, upon or within any public property or public right-of-way of the metropolitan government for the purpose of selling or offering for sale any goods, food, wares, merchandise, ~~services~~, or products of any kind, nor shall any person sell or offer for sale, upon or within any public property or public right-of-way of the metropolitan government, any goods, food, wares, merchandise, ~~services~~, or products of any kind, including the display or exhibition of animals for payment or gratuity. The prohibitions contained in this subsection shall not affect or apply to any agreement with, or the written approval of, the respective department, board, agency, officer, or other person having control or custody of that particular property.

SUBSTITUTE ORDINANCE NO. BL2023-113

An ordinance approving Amendment Number 1 to Contract number 6488663 between the Metropolitan Government of Nashville and Davidson County (“Metro”) and Axon Enterprise, Inc., to add an optional renewal term of up to 120 months and to increase the value of the contract and to require quarterly reports from the Metropolitan Nashville Police Department to the Metropolitan Council related to the use of tasers during the term of this contract.

WHEREAS, Metro previously entered a sole source contract, contract number 6488663 approved by Resolution RS 2022-1365, with Axon Enterprise, Inc., to provide tasers, taser cartridges and accessories for the Metropolitan Nashville Police Department; and,

WHEREAS, the parties desire to amend the contract to add an optional 5-year renewal term, and increase the overall value, among other things; and,

WHEREAS, Section 4.12.160 of the Metropolitan Code of Laws limits the term of contracts for supplies to sixty (60) months, unless otherwise authorized by Metropolitan Council; and,

WHEREAS, it is essential that Metro Nashville Police Department has tasers and taser accessories for the safety of MNPDP Officers and Metro Citizens; and,

WHEREAS, it is in the best interest of the Metropolitan Nashville Police Department to have the option to extend the term of contract number 6488663.

NOW THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. That Amendment Number 1 to contract number 6488663 between Axon Enterprises, Inc. and the Metropolitan Government of Nashville and Davidson County, a copy of which is attached hereto and incorporated herein, is hereby approved, and the Metropolitan Mayor is authorized to execute same.

Section 2. That further amendments to contract number 6488663 shall be approved by resolution of the Metropolitan Council receiving at least twenty-one (21) affirmative votes.

Section 3. That, during the term of this contract, the Metropolitan Nashville Police Department shall provide a report to the Council at the end of each quarter regarding its use of tasers. Such report shall include the number of taser deployments, the average number of taser cartridges used per incident, the number of times a firearm was used by MNPDP officers in addition to a taser deployment, and a summary of incidents where an individual subject to the taser deployment suffered an injury directly related to the taser deployment.

Section 3 ~~4~~. This ordinance shall take effect from and after its adoption, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.
