The District 51 seat in the Tennessee State House of Representatives was vacated by the passing of Representative Bill Beck on June 4, 2023. Pursuant to Section 3.04 of the Metropolitan Charter and Rule 49 of the Council Rules of Procedure, nominations will be taken followed by an election of an interim successor.

The President called for nominations to fill the vacancy in the District 51 seat in the Tennessee House of Representatives. Council Member Benedict nominated Mr. Anthony Davis. There being no further nominations, the President announced that nominations were closed and a vote to approve the election of Mr. Anthony Davis will be held.
