

Overview of Becoming the 2026 Host City: Process & How to Apply



Solicit Interest & Application: September 2024 - December 2024

Step 1: Letter of Interest

Submit a one page letter that confirms you have reviewed this request in detail. Highlight your commitments to the outlined responsibilities, and confirm that you will submit the full application to host the 2026 conference by December 13th, 2024. See page 6 for detailed instructions.

Due: End of day on Monday, October 7th, 2024.

• Step 2: Application

Submit a 4 page PDF application that outlines your staff and organizational capacity, your approach to Walkshops, and a shortlist of viable venues in your city. See page 7 for detailed instructions.

Due: End of day on Friday, December 13th, 2024.

Selection: January - February 2025

- Step 3: NACTO will identify the top host prospects. We might schedule a brief Zoom conversation if we have outstanding questions. NACTO may ask to arrange a staff visit to tour venues and meet in-personearly February 2025
- Step 4: NACTO staff will make a recommendation to the NACTO Board of the host city we think would be the best fit for the 2026 Designing Cities Conference mid February 2025
- Step 5: We will notify the selected host of the Board's decision mid to late February 2025

Preparation for announcement at Designing Cities: March - May 30th, 2025

• Step 6: We will work closely with the selected 2026 host to prepare for an announcement at our 2025 conference on May 30th, 2025.

Why Host the Designing Cities Conference?

Hosting NACTO's annual Designing Cities Conference puts your city and agency at the forefront of the conversation about safe, sustainable, equitable transportation. Hosting Designing Cities is both an opportunity and a major commitment for your agency that can bring your agency the following benefits:

Hosting NACTO puts your city in the national spotlight: The conference convenes transportation peers from around the country to your city to learn about what you're doing, and bring their own ideas. The conference also receives significant media attention. Leaders in transportation from around the country travel for the event.

Showcase your city: The primary work of the host city is to develop, plan, and execute ~55 Walkshops. Participants don't spend the conference in one hotel, they go on host-led tours of your city to see your infrastructure, innovations, and projects firsthand and hear about them from your staff and partners.

Benefits for agency staff: At the conference, the accomplishments of your staff are on full display for their peers around the country. We often hear that the host city staff feel like celebrities that week! The planning process helps increase awareness of the work happening across your departments. Staff at hosting cities say they got to work with people they had never worked with before.

Benefits for elected officials and city leaders: Bringing the NACTO conference to your city brings the momentum of an engaged and invested movement of 100 cities. The conference is a great opportunity to make strategic announcements, elevate your accomplishments, put your leaders in front of a large audience both during the conference and in the media, and otherwise creatively leverage the fact that 1,000 transportation practitioners and key leaders are in your city for nearly a week.

Hosting the conference brings the local ecosystem together on transportation issues: Planning the conference requires partnerships with other agencies, local companies and foundations, elected officials, non-profits, and more. The conference is a great opportunity to rally your city, region, and key partners around safe, sustainable, equitable transportation.

Past Designing Cities hosts: New York City, Phoenix, San Francisco, Austin, Seattle, Chicago, Los Angeles, Toronto, Boston, Cambridge and Somerville, Denver, Miami-Dade County, and Washington, DC (hosting the 2025 conference).

The Role of the Designing Cities Host City

Hosting the Designing Cities Conference is no small task - it requires a major commitment of staff time and agency resources to make it a success and to reap the full benefits as host.

Hosting Designing Cities requires a 14-month commitment. Fourteen months out from the conference, you will begin working with NACTO to prepare for the announcement. Active planning for your conference begins 12 months out, with the work required picking up substantially 9 months out. It requires the involvement of dozens of staff at your agency and the support of your leadership. We are targeting early-mid May 2026 for the conference, avoiding dates too close to Mother's Day or Memorial Day, but are happy to discuss the dates in partnership with the host.

Timeline, with the details to follow:



Host Planning Committee

- Collaborate with NACTO to define a structure for planning the conference and designate point people
 internally in your agency to manage each planning area. We recommend a structure of four
 subcommittees that map to your host responsibilities: Walkshops; Partnerships and Fundraising;
 Communications; and Welcoming (travel tips, local activations, unique-to-your-city activities).
- Designate a conference lead to oversee the host planning committee internally and work closely with the NACTO team, meeting every 1-2 weeks. This person should be senior and tenured enough to corral the right people and resources, and have the capacity in their role to project manage throughout the ~14 months of planning.

Walkshops

- Develop, plan, and execute ~55 Walkshops (35-40 unique Walkshops that happen on two days of the
 event, and ~15 longer Walkshops on the final day of the event). This often requires hundreds of staff and
 volunteers between ideation of what tours should happen, development of routes and planning the tour,
 and day-of leading and support.
- Identify a Walkshop Manager to project manage and lead the process. This can take up to 60% of their time.

- Supply, or facilitate the partnerships needed to attain: transit passes, bikes, and other devices needed for the Walkshops (in the past we have also had scooters and kayaks - it depends on your city!) Identify and secure a staging area for these devices and the launch of Walkshops near the venue.
- Involve community based organizations that shaped the projects you are showcasing

Communications, Marketing, and Branding

- Work closely with the NACTO team to leverage the momentum around the conference through media channels. Liaise with local press. Supply high quality transportation and livability themed photos of your city and quotes from leaders supporting the conference for our brochures and website
- Identify a Conference Communications Manager to lead this work. They should be able to dedicate
 around 1-4 hours per week to meeting with NACTO staff, taking on agreed upon tasks, and coordinating
 internally as needed.

Partnerships and Fundraising

- Collaborate closely with NACTO on securing sponsors and delivering benefits by identifying local
 prospects and leveraging the opportunity to secure Walkshop sponsors (coordinating with the Walkshop
 team to identify what tours might be a good fit to be sponsored by local consulting firms, engineering
 companies, micromobility companies, etc).
- Identify a Conference Partnerships Manager to lead this work. They should be able to dedicate around 1-4
 hours per week to meeting with NACTO staff, taking on agreed upon tasks, and coordinating internally
 and externally as needed.

Welcoming Committee: Fun & Local Activations

- Plan Neighborhood Dinners to promote social connection and encourage participants to experience
 different neighborhoods. Identify activities, destinations, etc that make your city unique so that people
 can plan their trips. For example, past hosts have held a Ciclovia event and Open Streets event the week
 of the conference.
- Identify a Conference Welcoming Manager to lead this work. They should be able to dedicate around 1-2
 hours per week to meeting with NACTO staff, taking on agreed upon tasks, and coordinating internally
 and externally as needed.
- Optional: Coordinate city maintenance and beautification to enhance the Walkshop experience and/or use the opportunity to move forward with projects such as quick builds, pop-ups, installing bike parking - get creative!

Member Program Committee:

Designate one person on your team to be part of the conference's Member Program Committee: a group
of 10 staff from NACTO member cities that each fully develop and plan a peer session at the conference.
We anticipate that this commitment will take approximately 20-30 hours of time, over the course of
November 2025-May 2026.

Attend the Conference

• Your staff should be supported with the time and funds to register for and attend the conference.

Proposal - Step 1: Letter of Interest

DUE: End of day on Monday, October 7th, 2024 via email to hannah@nacto.org and alana@nacto.org

Provide us with a 1-page letter of interest that lets us know you plan to apply and that you understand the level of commitment required and confirm that your city has capacity to host the conference in 2026. Please outline why your city should host NACTO's Designing Cities Conference in 2026. The letter of interest should come from the Director or Commissioner of Transportation of your city and should affirm the leadership and agency-wide commitment to taking on the role of hosting the conference.

In your letter, please include a list of dates that would work well for your city and any helpful context. We typically aim for May of each year, ideally a Tuesday-Friday, avoiding proximity to Mother's Day and Memorial Day. In the past, we've aligned with Ciclovia and Open Streets events and are always excited about such opportunities.

Questions to consider in your response include:

- What are the vital issues your city is addressing related to transportation?
- How does your agency's vision for transportation align with <u>NACTO's mission and values</u>?
 - How will you leverage this opportunity to highlight your staff and their commitment to fostering community, centering justice, striving for impact, and leading with imagination?
- How will hosting the conference help catalyze your city's work: what will change locally because NACTO came to this city?
- How can your city's work inspire NACTO's other members across North America: what will change nationally because NACTO went to this city?
- What commitments in regards to transportation do you have locally and regionally, and share with community partners, other agencies, and other governments?

To apply, please send us a compiled PDF that replies to the following prompts. We also invite you to include any letters of support from local organizations, city government, or other partners that will support you in bringing the conference to your city.

Staff and Organizational Capacity (1 page)

Please outline your staff and organizational capacity to host a national conference, and outline your approach to the following roles and responsibilities of the host city.

NACTO and the host city collaborate across a number of core work areas for the conference: Walkshops, Communications and Marketing, Partnerships and Fundraising, and Welcoming participants through fun and local experiences/activations. The host city designates a conference planning lead and a planning committee. NACTO and the planning committee will meet once a month, with subcommittee meetings as needed. The Walkshop Manager will give 60% of their time for the 9 months out from the conference, while the other committee leads can likely accommodate the work into their day to day.

Questions to answer in more depth in your response:

- Please describe your approach to identifying this committee and confirm their capacity. Can you confirm
 that the group will be equipped to take on their roles? How will you ensure the committee is diverse in
 background and perspective?
- How would you ensure there is capacity for Walkshop planning and development?
- Who will you partner with, and how? Please consider local community based organizations and advocates, transit agencies, micro mobility operators, and more.
- Do you have any other ideas for how we can highlight community leaders in transportation, partnerships, and ensure we include diverse voices in your city?

Conference Venue, Hotel, Opening Reception, and Local Experience (list format, 1 page)

Nearly 1,000 people of all different backgrounds and identities will travel to your city for this conference, providing host cities the opportunity to showcase what makes them unique. In addition, it is essential that we provide our participants an experience in which they feel safe and welcomed. The conference venue and opening reception should be accessible via walking or public transportation.

 - Capacity for at least 1,000 people in the main ballroom space and throughout the conference area
 - At least 8 breakout rooms with capacity for ~ 150 each, after audio visual
 - Fully ADA compliant

- Full service (catering, furniture, rigging/lighting, accepts deliveries)
- Must be within a walkable, bike and transit-friendly neighborhood or downtown part of the host city that will be safe and welcoming for the full diversity of the NACTO community
- Must be in proximity to where you can secure the space for walkshop staging/departure and for bike parking
- o Nice to haves: venue commitment to sustainability and zero waste policies, outdoor space
- 2-3 hotels for a room block (if the conference venue itself is not a hotel)
 - within proximity to the venue
 - o same as above in regards to neighborhood (it should share a neighborhood with the venue
- 3-4 venues for our opening reception
 - o capacity for at least 700
 - full service venue (catering and furniture are in-house)
 - o ideally, a mix of indoor and outdoor space

Walkshops (2 pages)

Developing, planning, and executing ~55 Walkshops is one of the most rewarding and time-intensive tasks hosts cities undertake. Walkshops are the host city's stamp on the conference. The work of executing Walkshops will take the most time and effort of all host city responsibilities.

Executing successful Walkshops involves the efforts of hundreds of people: city staff that design and lead them, local partners that provide insight and join the tours to provide additional perspectives, volunteers that join to ensure the safety of participants, transit agencies that provide passes, micromobility operators that provide bikes (and maybe scooters!)

In your response, please confirm your ability to fulfill each of the following required responsibilities and outline any initial approaches/ideas for each item:

- Hire and fund, or designate an existing staff to be, a Walkshop manager. The role should be about 60% of the person's time for at least 9 months before the conference. The Walkshop manager will coordinate with city staff to finalize the logistics for each walkshop, including designing the tours, production of maps, and speaker selection.
- Commitment to involving local community based organizations on each Walkshop
- Provide transit passes for the duration of the conference or help facilitate the partnership required to secure transit passes. Provide local micromobility options that will be featured in walkshops (bikes and/or scooters).
- Provide any rentals needed, such as shuttles

• Secure space for Walkshop departure and micromobility staging near the conference venue through permitting or partnerships as needed. Please consider how walkable and bikeable the areas where we might host the conference are.

In addition to these logistic details, please include a description of how the city will select projects, plan tours, and lead tours and a list of some of the projects, partnerships, and programs that you would like to feature.

Questions to consider:

- Are there major transportation projects in the works, or recent accomplishments?
- What interesting viewpoints on the city core can you showcase, like a kayak tour?
- What are your exciting new achievements, like a light-rail line or protected bike lane?
- What innovative partnerships with community groups made a project possible?

Staff and Organizational Capacity

The Nashville Department of Transportation and Multimodal Infrastructure (NDOT) is well-prepared to host the NACTO Designing Cities Conference in May 2027. Our approach to identifying the planning committee involves a thorough vetting process to ensure members are highly capable and equipped to take on their respective roles. The committee will consist of experienced professionals from various Metro departments and agencies like NDOT, Metro Planning Department, Metro Parks Department, and WeGo (MTA), alongside community-based organizations, including transportation planning, urban design, policy and community engagement, to ensure a holistic perspective. We are committed to forming a diverse committee by including members from different backgrounds, genders, ethnicities, and professional experiences, ensuring a range of perspectives and ideas.

To ensure adequate capacity for Workshop planning and development, we will leverage our existing, experienced staff, who have a proven track record in organizing large-scale events and urban planning initiatives. Additionally, we plan to allocate dedicated resources through NDOT's budget and personnel to the Walkshops to ensure they are well-organized and impactful. This includes partnering with local experts who can provide valuable insights into the unique characteristics and challenges of Nashville's neighborhoods.

Collaboration with local community-based organizations and advocates, transit agencies, micro-mobility operators, and other stakeholders is a cornerstone of our planning process. We will partner with groups such as Walk Bike Nashville, Civic Design Center, the Nashville Area Chamber of Commerce, WeGo Public Transit, Greenways for Nashville, Urban Land Institute and various neighborhood associations to ensure broad community involvement. These partnerships will help us tap into local knowledge, foster community buy-in, and ensure the conference is grounded in the experiences and needs of Nashville residents.

To highlight community leaders in transportation and ensure we include diverse voices, we will incorporate local leaders, advocates, and innovators. We also plan to showcase successful local projects and initiatives that exemplify collaboration and innovation in urban transportation. Notable local projects and initiatives, such as the 12th Avenue South Complete and Green Street and the 31st Ave Vision Zero Safety Project, will be showcased. Through these efforts, we aim to create a platform where diverse voices are heard and celebrated, reinforcing the importance of inclusive, community-driven urban planning.



Walkshops

Developing, planning, and executing approximately 55 Walkshops for the NACTO Designing Cities Conference in Nashville is an exciting opportunity that our team is well-equipped to handle. Here's how we plan to fulfill each required responsibility and our initial approaches and ideas for this endeavor:

Walkshop Manager

We will designate an experienced staff member as the Walkshop manager, dedicating approximately 60% of their time for at least 9 months before the conference. This manager will be responsible for coordinating with city staff to finalize logistics, including designing tours, producing maps, and selecting speakers. The role requires strong organizational skills, detailed knowledge of Nashville's infrastructure and urban projects, and excellent communication abilities to liaise between various departments and stakeholders.

Commitment to Community Involvement

To ensure the Walkshops are inclusive and representative of our community, we will partner with local community-based organizations for each Walkshop. This includes groups like Walk Bike Nashville, Civic Design Center, neighborhood associations, and advocacy groups that reflect the diverse demographics and perspectives of our

city. We aim to ensure every Walkshop is co-led by community representatives who can provide authentic insights and foster meaningful dialogue. This involvement will not only enrich the Walkshops but also strengthen community ties and promote local engagement in urban development discussions.

Providing Transit Passes and Micomobility Options

We will facilitate partnerships with WeGo Transit to provide transit passes for the duration of the conference. Additionally, we will feature local micromobility options, such as bikes and scooters, by collaborating with operators Lime, Spin, and Bird. These options will be integrated into the Walkshops to demonstrate their practical use in Nashville's urban mobility environment and to encourage sustainable transportation choices. We plan to offer guided rides and hands-on experiences with these micromobility options, highlighting their benefits and challenges in Nashville's urban setting.

Securing Space for Walkshop Departure and Micromobility Staging

We will secure space near the conference venue for Walkshop departure and micromobility staging through necessary permits or partnerships. We will ensure these areas are walkable and bikewable, considering the convenience and safety of attendees. NDOT will work with local businesses to ensure these spaces are equipped with necessary amenities.

Project Selection and Tour Planning:

Our City boasts several significant transportation projects and accomplishments that will be highlighted during the Walkshops. Key projects include:

- 12th Avenue South Complete and Green Street: A prime example of sustainable urban design
- WeGo Neighborhood Transit Centers: Enhancing public transit accessibility
- Shelby Bottoms Greenway Connection: Learn about the connection between the greenway and protected bike lanes.
- 31st Ave Vision Zero Safety Project: Focused in improving road safety
- Historic Germantown: Nashville's first suburb and officially designated as a city arboretum.
- TOD: WeGo Star: Showcasing transit-oriented development projects along the Music City Star route, highlighting the integration of public transit with development.
- **Connect Downtown:** Showcasing our innovative approach to creating micromobility corrals in the Downtown core.

Interesting Viewpoints and Achievements:

We will showcase unique aspects of Nashville, such as kayak tour along the Cumberland River, offering a different perspective of the city core. Other exciting achievements include recent expansions in protected bike lanes and the exploration of BRT possibilities. We will also do a deep dive in the *Choose How You Move Transportation Improvement Program* as Nashville begins delivering on important transit and infrastructure projects.

Innovative Partnerships:

Our innovative partnerships with community groups, like the successful collaboration with Walk Bike Nashville for the Tour de Nashville and Open Streets event during the conference, will be featured to illustrate how community involvement drives our projects (Figure 8 and Figure 9). This event will highlight the role of community advocacy in shaping transportation policy and infrastructure, showcasing real-life examples of successful public engagement.

Rentals and Logistics:

We will arrange rentals for shuttles, ensuring seamless transportation during the Walkshops. Coordination with rental agencies will ensure all logistics are handled efficiently. All Walkshops will be within walking, cycling, or transit, with detailed schedules and routes provided to ensure punctuality and convenience.

Additional Ideas to Highlight Community Leaders:



Dear NACTO Selection Committee,

I am writing in support for Nashville's application to host the NACTO Designing Cities Conference. Nashville is a uniquely vibrant & hospitable city with a commitment to sustainable, multi-modal transportation demonstrated most notably in recent days by the resounding passage on November 5th of the "Choose How You Move" referendum for dedicated transportation funding.

Nashville's Metropolitan Council has for many years prioritized increased funding for multimodal transportation and crafted and passed major supportive policies, such as enhanced sidewalk and street-tree requirements, speed limit reductions, and elimination of parking minimums and implementation of parking maximums in our urban zoning overlay. Metro Council Members provided formative input for the Transportation Improvement Program and voted in unanimous support to bring the program to the ballot.


