Call to Order and Invocation

The Metropolitan Council met in regular session on this date at 6:30 p.m. in the Metropolitan Courthouse.

The invocation was offered by Rabbi Laurie Rice of Congregation Micah.

Approval of Minutes

The minutes of the regular meeting on March 5, 2019 were approved.

Elections and Confirmations

Community Education Commission

Nomination of Ms. Jane-Coleman Cottone to fill an unexpired term ending on August 2, 2019.

The Rules, Confirmations, and Public Elections Committee recommended the nomination. Council Member Murphy moved for election by acclamation, which motion was seconded and adopted by a unanimous vote of the Council.

Work Release Commission

Proposed amendment to Rule 28 to the Rules of Procedure of the Metropolitan Council.

The Rules, Confirmations, and Public Elections Committee recommended an amendment to the proposed rule change, and recommended the rule change as amended. Council Member Allen moved to suspend the Rules of Procedure to introduce a late amendment. Without objection, Council Member Allen moved the amendment, which motion was seconded and adopted by a voice vote of the Council. Council Member Rhoten moved to approve the proposed rule change as amended, which motion was seconded and approved by a voice vote of the Council.

Upon motion duly seconded, the bill passed first reading and was referred to the Public Safety, Beer, and Regulated Beverages Committee by a voice vote of the Council.

Bill BL2019-1544

An ordinance to approve an affiliation agreement by and between Vanderbilt University and The Metropolitan Government of Nashville and Davidson County to provide student clinical instruction and training with the Davidson County Drug Court.

The bill was approved by the Planning Commission. Upon motion duly seconded, the bill passed first reading and was referred to the Budget and Finance Committee, the Parks, Library, and Arts Committee, and the Planning, Zoning, and Historical Committee by a voice vote of the Council.

An ordinance authorizing The Metropolitan Government of Nashville and Davidson County to abandon existing sanitary sewer and water mains, a sanitary sewer manhole, a fire hydrant assembly and easements and to accept new water and sanitary sewer mains, sanitary sewer manholes, fire hydrant assemblies and easements for properties located along Belmont Boulevard, Bernard Avenue and Compton Avenue (MWS Project Nos. 18-WL-109 and 18-SL-135 and Proposal No. 2019M-010ES-001).

The bill was approved by the Planning Commission. Upon motion duly seconded, the bill passed first reading and was referred to the Planning, Zoning, and Historical Committee and the Public Works Committee by a voice vote of the Council.

Bill BL2019-1551

An ordinance authorizing The Metropolitan Government of Nashville and Davidson County to abandon existing sanitary sewer main and easements for property located at 1022 9th Avenue South (MWS Project No. 18-SL-270 and Proposal No. 2019M-013ES-001).

The bill was approved by the Planning Commission. Upon motion duly seconded, the bill passed first reading and was referred to the Planning, Zoning, and Historical Committee and the Public Works Committee by a voice vote of the Council.

Bill BL2019-1552

An ordinance authorizing The Metropolitan Government of Nashville and Davidson County to abandon existing sanitary sewer main, a sanitary sewer manhole and easement and to accept new sanitary sewer main, sanitary sewer manholes, an adjustment to an existing sanitary sewer manhole and easements, for property located at 3711 Dickerson Pike (MWS Project No. 18-SL-258 and Proposal No. 2019M-015ES-001).

The bill was approved by the Planning Commission. Upon motion duly seconded, the bill passed first reading and was referred to the Planning, Zoning, and Historical Committee and the Public Works Committee by a voice vote of the Council.

Bill BL2019-1553

An ordinance authorizing The Metropolitan Government of Nashville and Davidson County to abandon existing sanitary sewer main, a sanitary sewer manhole and easements and to accept new sanitary sewer main, sanitary sewer manholes and easements, for property located at 2995 Sidco Drive (MWS Project No. 18-SL-154 and Proposal No. 2019M-016ES-001).

The bill was approved by the Planning Commission. Upon motion duly seconded, the bill passed first reading and was referred to the Planning, Zoning, and Historical Committee and the Public Works Committee by a voice vote of the Council.

Bill BL2019-1554

An ordinance authorizing The Metropolitan Government of Nashville and Davidson County to abandon existing water main and easement and to accept the relocation of a fire hydrant assembly, a new fire hydrant and easement, for property located at 4101 Charlotte Avenue (MWS Project No. 18-WL-214 and Proposal No. 2019M-019ES-001).

The bill was approved by the Planning Commission. Upon motion duly seconded, the bill passed first reading and was referred to the Planning, Zoning, and Historical Committee and the Public Works Committee by a voice vote of the Council.

Bill BL2019-1555

An ordinance authorizing The Metropolitan Government of Nashville and Davidson County to accept new water main, fire hydrant assemblies and easements, for property located at 833 Watts Circle (MWS Project No. 17-WG-203 and Proposal No. 2019M-021ES-001).

The bill was approved by the Planning Commission. Upon motion duly seconded, the bill passed first reading and was referred to the Planning, Zoning, and Historical Committee and the Public Works Committee by a voice vote of the Council.

Bill BL2019-1556

An ordinance authorizing The Metropolitan Government of Nashville and Davidson County to abandon existing water main and easement and to accept new water main and easement for property located at 900 Rosa L. Parks Boulevard (MWS Project No. 18-WL-190 and Proposal No. 2019M-020ES-001).

The bill was approved by the Planning Commission. Upon motion duly seconded, the bill passed first reading and was referred to the Planning, Zoning, and Historical Committee and the Public Works Committee by a voice vote of the Council.

Bill BL2019-1557

An ordinance authorizing The Metropolitan Government of Nashville and Davidson County to abandon existing easement rights for former Alley #120, located at 821 Palmer Place (Proposal No. 2019M-014ES-001).

The bill was approved by the Planning Commission. Upon motion duly seconded, the bill passed first reading and was referred to the Planning, Zoning, and Historical Committee and the Public Works Committee by a voice vote of the Council.

Bill BL2019-1558

An ordinance to amend the Geographic Information Systems Street and Alley Centerline Layer for the Metropolitan Government of Nashville and Davidson County by abandoning portions of Alley Number 1863 right-of-way (Proposal Number 2019M-005AB-001).

The bill was approved by the Planning Commission and approved by the Traffic and Parking Commission. Upon motion duly seconded, the bill passed first reading and was referred to the Planning, Zoning, and Historical Committee, the Public Works Committee, and the Traffic, Parking, and Transportation Committee by a voice vote of the Council.

Bill BL2019-1559

An ordinance to amend Title 17 of the Metropolitan Code of Laws, the Zoning Ordinance of The Metropolitan Government of Nashville and Davidson County, by changing from RS5 to R6 zoning for property located at 616 Vester Avenue, approximately 230 feet southeast of Weakley Avenue (0.2 acres), all of which is described herein (Proposal No. 2018Z-103PR-001).

The bill was approved by the Planning Commission. Upon motion duly seconded, the bill passed first reading and was referred to the Planning, Zoning, and Historical Committee by a voice vote of the Council.

Bills on Second Reading

Bill BL2018-1404

An ordinance amending Section 6.80.550 and Section 12.08.150 of the Metropolitan Code of Laws to remove certain storage and impound fees for recovered stolen vehicles.

The bill was approved with an amendment by the Budget and Finance Committee and recommended for deferral at the request of the sponsor by the Public Works Committee and the Traffic, Parking, and Transportation Committee. Council Member Rhoten moved to defer the bill, which motion was seconded and approved by a voice vote of the Council. Pursuant to Rule 23, the bill is deferred indefinitely.

Bill BL2019-1476

An ordinance declaring surplus and approving the disposition of a parcel of real property known as 0 Brick Church Pike (Map/Parcel No. 06000007000) (Proposal No. 2019M-005PR-001).

The bill was approved by the Planning Commission, given no recommendation by the Budget and Finance Committee and the Planning, Zoning, and Historical Committee and approved by the Education Committee and the Parks, Library, and Arts Committee.
