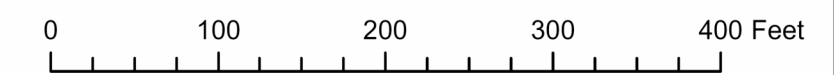

On behalf of the Metropolitan Planning Commission, the following item, referred to the Commission as required by the Metro Charter, has been recommended for *approval* to the Metropolitan Council:

*A request for the acceptance approximately 1,249 linear feet of eight-inch water mains (DIP), one fire hydrant assembly and approximately 1,211 linear feet of eight-inch sanitary sewer mains (PVC), nine sanitary sewer manholes and any associated easements to serve the Wildflower Phase 1 development.*
