On behalf of the Metropolitan Planning Commission, the following item, referred to the Commission as required by the Metro Charter, has been recommended for *approval* to the Metropolitan Council:

*A request for the abandonment of a portion of a 10-foot public stormwater drainage easement rights shown on the plat of Storage Inn Center (Book 9700, Page 260), Davidson County Register of Deeds. 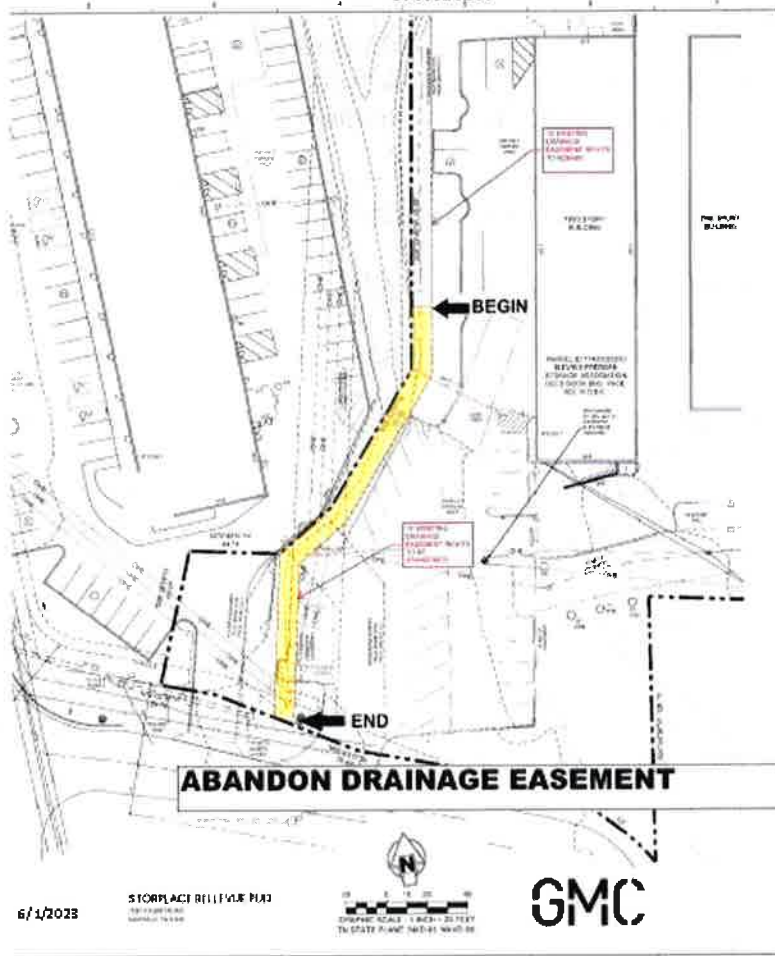

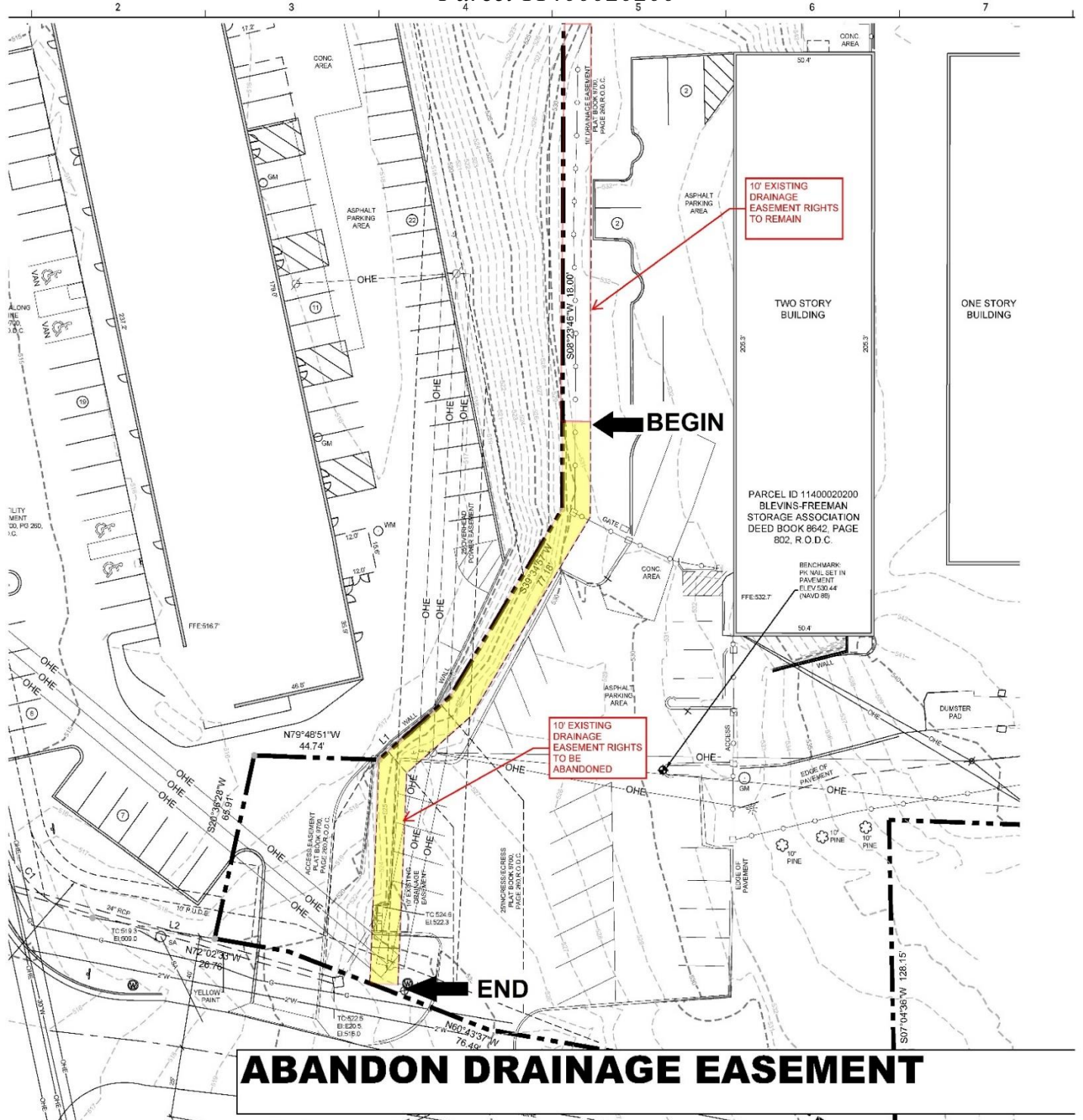

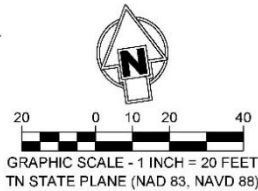
