## STATE HOMELAND SECURITY STRATEGY

**Goal from State Strategy:** Enhancing the protection of soft targets and crowded places as well as enhancing information sharing and cooperation and addressing emergent threats.

**Objectives:** Enhancing the protection of soft targets and crowded places within Homeland Security District 5 while also enhancing information and intelligence sharing and cooperation with other agencies and addressing emergent threats.

## DETAILED PROJECT DESCRIPTION

## Enhancing the Protection of Soft Target / Crowded Places

Terrorists and other extremist actors, who have demonstrated the intent and capability to attack soft targets—crowded places, continue to pose a risk domestically and abroad. These adversaries have the ability to access and surveil potential targets with relative ease and use various tactics to carry out attacks, including small arms, improvised explosive devices, edged weapons, and vehicle ramming. The District 5 response objective is to enhance and expand capabilities of its tactical teams to better prevent, detect, and respond to a terrorist act committed against soft targets and crowded places.

Funds received from FY20 Homeland Security Grant Program will enhance the protection of soft targets and crowded places by increasing the ability of tactical teams to surveil and respond to soft target attacks during the night time hours or in buildings without light. This investment will also improve the ability to extend the vision of the tactical team with an extreme low light sensitivity and thermal fusion technology pole camera that will extend up to 17 feet in length.

Rutherford County will be receiving three PVS-31A night vision binoculars with mounts, gain control, and white phosphorous tubes. Davidson County will be receiving one PVS-31A night vision binocular with mount, gain control, and white phosphorous tubes and a

To enhance local HAZMAT, IED and CBRNE response capabilities for soft target and large crowd emergencies and activities.

## DETAILED PROJECT DESCRIPTION

This investment will expand capabilities and enhance the response and application of resources for Tennessee Homeland Security District 5. While Tennessee Task Force 2 (TNTF2) Urban Search and Rescue Team, established in 1995, is based in Davidson County, it is also a statewide response asset. This project will help build their capability with increased training for the TNTF2 team. The Nashville Fire Department Hazmat Team (Type I) will benefit by expanding capabilities and enhancement of response and application of resources for hazmat and WMD threat related incidents by increasing their capability of air sampling and detection devices. TNTF2, as well as other specialized teams throughout the district, have worked diligently over the past 9 years to prepare specialized capabilities to respond to emergency incidents of all scopes and magnitude. These teams have attended training and exercises, both locally and nationally, to gain knowledge, skill and ability to work in numerous types of environments. The response equipment will continue to provide a safe and efficient response for citizens and responders locally and across the region. This, in turn, would expedite the mitigation and recovery process for the whole community. District 5 is expanding its ability to detect, respond, mitigate, and recover from incidents which may involve Hazmat, IED, or CBRNE elements and to reduce the overall loss of lives. The District 5 investment contains personal protective equipment and response equipment to outfit team members. Hendersonville Fire is requesting funding to purchase ballistic protection equipment. Rutherford, Murfreesboro Fire and Lavergne Fire request funding to purchase rescue gear and ensembles for Urban Search and Rescue. Smyrna Fire Department will be purchasing multi-purpose device for rope related rescue to support TNTF2 USAR. Wilson County is purchasing water rescue suits
