

AMENDMENT NUMBER 1 TO CONTRACT NUMBER L-6222 BETWEENTHE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY AND <<ASPIRING YOUTH ENRICHMENT SERVICES>>.

This Amendment is entered into on the day this document is filed with the Metropolitan Clerk's Office, by and between THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY (METRO) and Aspiring Youth Enrichment Services.

WITNESSETH

WHEREAS, the parties desire to modify the terms and conditions and to add or delete certain other terms and conditions to their original agreement dated July 2, 2024. Metro Contract numbered L-6222, hereinafter the "GRANT CONTRACT."

WHEREAS the parties desire to expand funding for FY '25 to add one program site at Sudekum public housing community to provide free and high quality 4-week camp in June 2025.

WHEREAS \$64,000 would be granted to create access to this summer camp for 50 youth residents of the Sudekum community in grades raising 5th through raising 9th who are residents of Nashville-Davidson County.

WHEREAS NAZA will appropriate the funds from FY '25 budget, and no new funding is requested from Metro, the parties hereby agree as set forth below:

This amendment affects the following changes to the contract:

Amend Clause C.1. Maximum Liability. In no event will Metro's maximum liability under this Grant Contract exceed \$486,520 (104 slots for afterschool, 160 slots for summer).
