A request for the acceptance of approximately 3,580 linear feet of 10-inch sanitary sewer mains (PVC), 18 sanitary sewer manholes, and the acquisition of permanent and temporary easements through negotiations, condemnation, and acceptance to serve the Darsey Subdivision development.




