On behalf of the Metropolitan Planning Commission, the following item, referred to the Commission as required by the Metro Charter, has been recommended for *approval* to the Metropolitan Council:

A request for the abandonment of approximately 300 linear feet of 6-inch water main (cast iron) and 524 linear feet of 8-inch water main (cast iron) and the acceptance of approximately 827 linear feet of 8-inch water mains (DIP), 605 linear feet of 8-inch sanitary sewer mains (PVC) and five sanitary sewer manholes to serve the Boscobel V & VI development.

The relevant Metro agencies (Metro Parks, Metro Public Works, Metro Water Services, Metro Emergency Communications, the Nashville Electric Service, Metro Finance – Public Property and the Metro Historical Commission) have reviewed the proposal and concur in the recommendation for approval. This request must be approved by the Metro Council to become effective. A sketch showing the location of the request is attached to this letter.

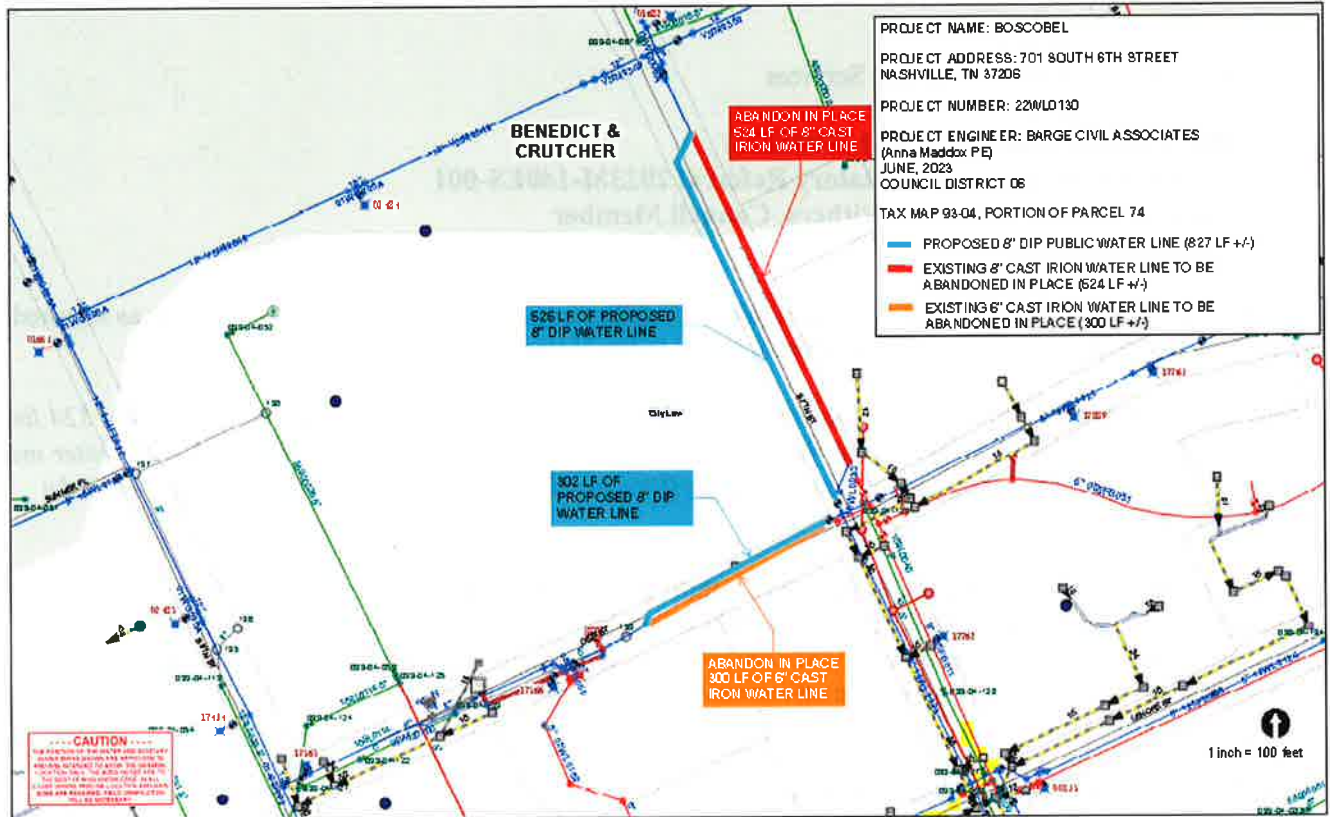

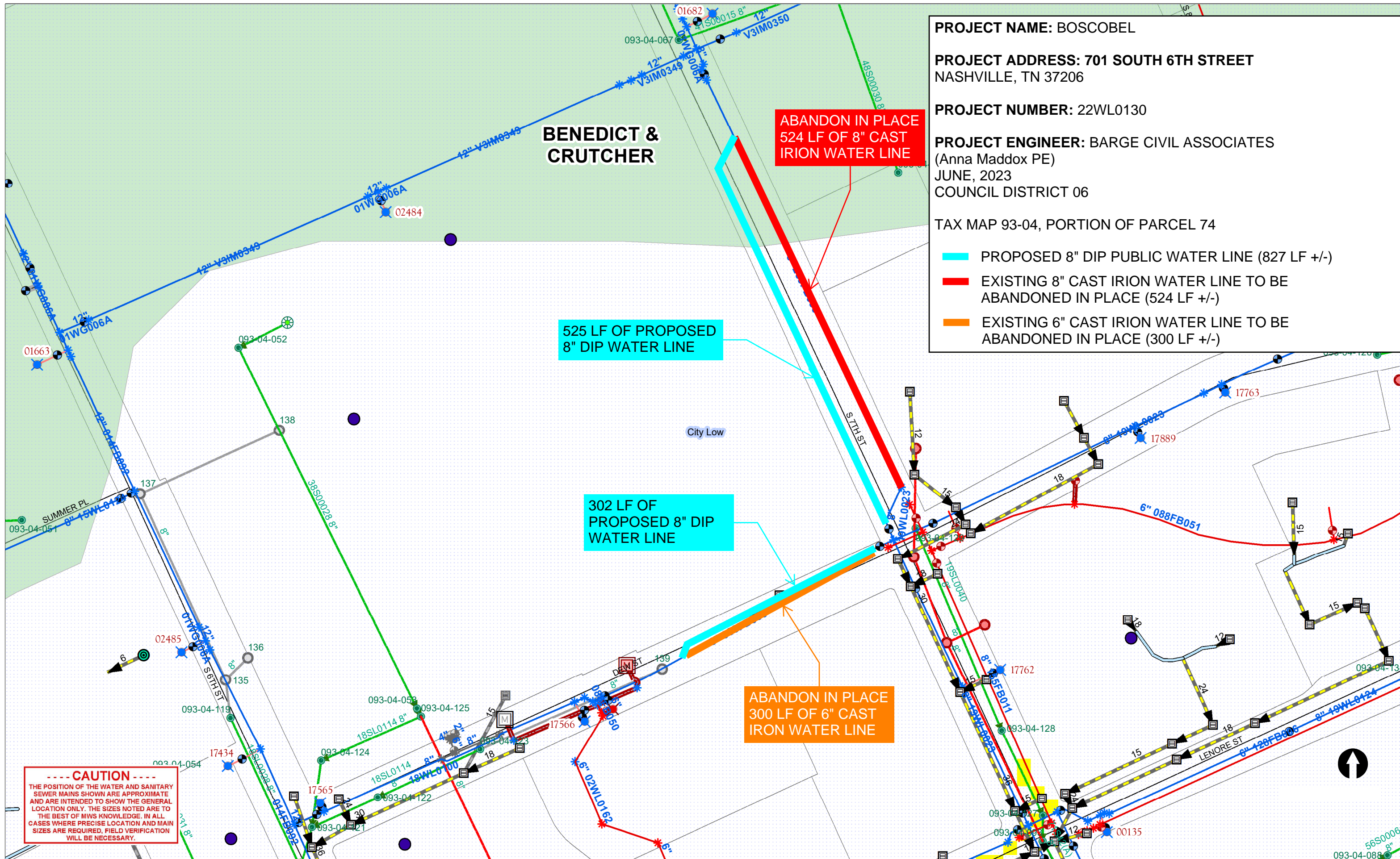

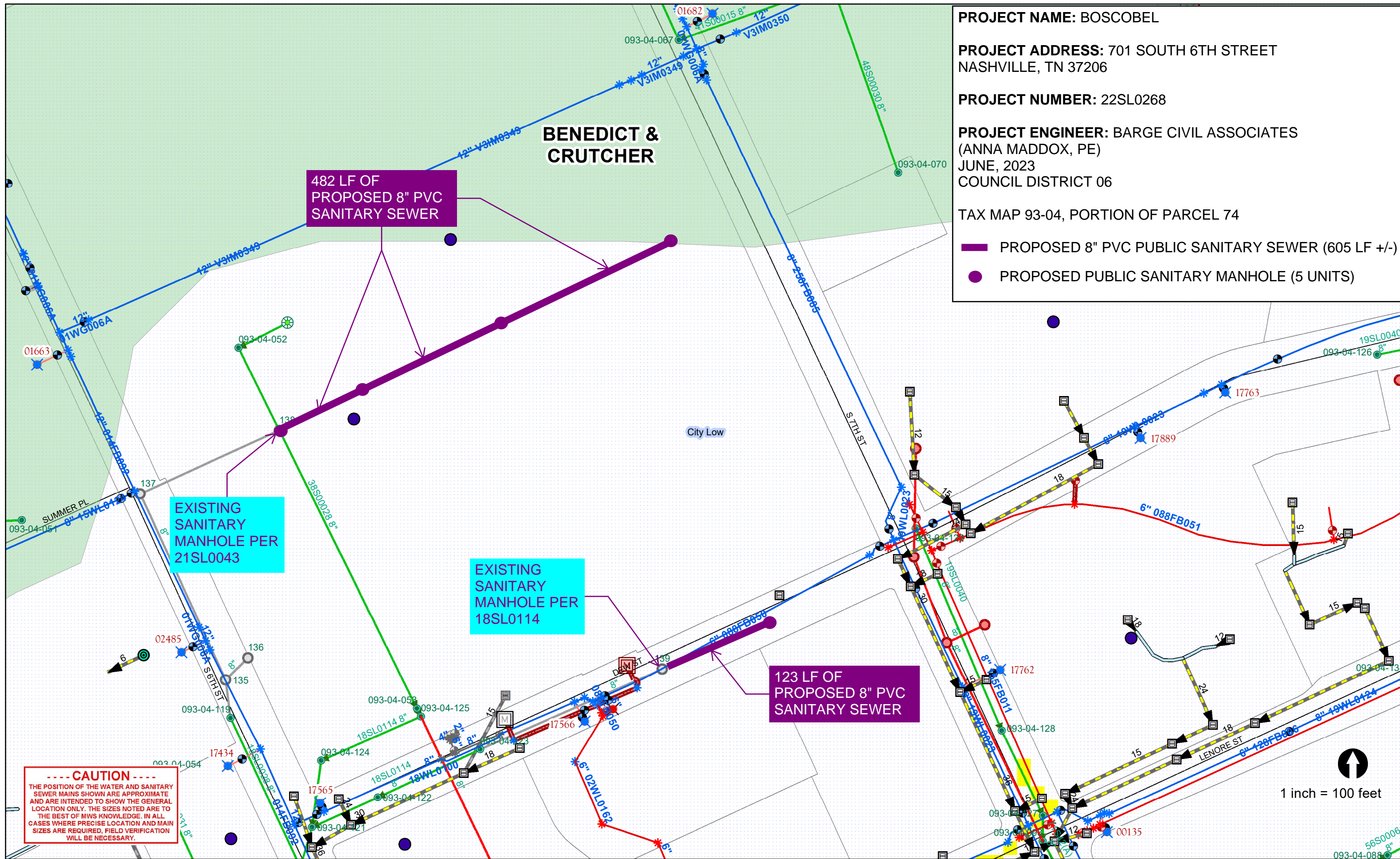
