Beyond animal sheltering, please describe how your organization serves pets and people in your community:	Metro Animal Care & Control (MACC) has their Safety Net Program, which was established to provide resources and assistance to our Davidson County / Nashville residents who are looking to surrender their pets. We are able to provide numerous resources to aid pet parents in times of hardship and need. MACC's Safety Net Program can help with medical costs, one-on-one dog and cat behavior training, pet food from our pet pantry, basic pet supplies, free spay / neuter vouchers, and help with re-homing options if needed. Our Safety Net Program was established at the end of 2017. Since then we have been able to help 346 pets in 2018, 936 pets in 2019, and 1,318 pets in 2020 so far stay in their home and with their families. At MACC we see the benefit of being a place of support and aid for our community and we want to be able to continue to provide our resources and care to those pet parents in the future.

Lauren Bluestone is the Director of Metro Animal Care and Control (MACC) and has been for almost four years. Bluestone has over 18 years of animal care and control experience, working with open admission shelters and shares a true passion for animal welfare. Lauren began her career as an animal caretaker at DuPage County Animal Control in Illinois and then became an animal control officer with Kane County (Illinois) Animal Control. At Kane County, she advanced into the role of Shelter Operations and Program Manager, managing the operations through private-public cooperation with Kane County Government and various non-profit rescue organizations. Lauren was superintendent of animal services for the City of Newport News, Virginia. She introduced new programs, formed many positive community relationships, and made staff training a priority. Most recently she has served the city of Nashville and Davidson County to promote and protect the health, safety, and welfare of pets and its people, as well as build partnerships within the community to promote responsible pet ownership, decrease the overpopulation of domestic pets through spay-neuter programs, and to place adoptable animals in good homes. In her role as director of MACC, Lauren is furthering the effort to continuously improve the quality of life for all species of animals throughout the community, as well as fostering the personal growth and development of animal care and control staff. With various partnerships, collaborations, and an amazing staff the shelter has seen a decrease in euthanasia from 86% in 2014 to a 10% average over the past year, an enhanced community education program, and a drastic increase in the productivity and efficiency of field services. Bluestone has a Bachelor's of Science in Zoology from University of Wisconsin-Madison, a Masters in Criminal Justice from Boston University, and a Master's in Public Administration from Northwestern University.

MACC works closely with Nashville Humane Association, Pet Community Center, SafPaw, Nashville Safe Coalition, Habitat for Paws, Friend's of MACC, and multiple local rescues.

While our shelter census is low, we have been taking in more medical cases while keeping healthy animals out in foster. With having many more medical cases in the shelter, this has increased our expenses with medical supplies. When members of our community find a healthy stray animal, we have been asking them to care for the animals and locate their owner on our behalf without the pet entering the shelter. We have received pretty positive feedback from the community, who have been very willing to help us with this. Our revenue has been down since we have waived our reclaim fees and adoption fees during this time. We have been relying on donations from the public for many of our supplies and revenue. Our community has been impacted by many businesses having to close and the large amount of job losses. We are seeing many of our community members unable to pay their bills or food, which we have used our donations to help with pet food for those without income. Our city's court is also closed, which has been tough on the animals involved in criminal cases because their length of stay increases and our costs to care for that animal increases as well. We know there are still uncertain times ahead, but we hope that with any funds awarded to us we will be able to take what we have learned thus far in adapting at the shelter and continue to overcome challenges and support our community.
