On behalf of the Metropolitan Planning Commission, the following item, referred to the Commission as required by the Metro Charter, has been recommended for *approval* to the Metropolitan Council:

*A request for the abandonment of approximately 293 linear feet of 12-inch sanitary sewer, two sanitary sewer manholes, 530 linear feet of 6-inch water main, and one fire hydrant assembly; and acceptance of approximately 264 linear feet of 12-inch sanitary sewer main (PVC), four sanitary sewer manholes, 532 linear feet of 8-inch water main (DIP), three fire hydrant assemblies; and any associated easements to serve the River Chase Apartments development.*

The relevant Metro agencies (Metro Parks, Metro Public Works, Metro Water Services, Metro Emergency Communications, the Nashville Electric Service, Metro Finance – Public Property and the Metro Historical Commission) have reviewed the proposal and concur in the recommendation for approval. This request must be approved by the Metro Council to become effective. A sketch showing the location of the request is attached to this letter.


