An MOU is utilized for contractual agreements within Metropolitan Government departments.

6. **Method of Accountability**: The CCR Project Director, Chemyeeka Tumblin, is responsible for supervising the OHS contract. Progress and performance will be monitored via monthly reports, monthly meetings with OHS staff and quarterly site visits to ensure technical assistance is provided to mitigate any challenges.

The Metro Public Health Department (MPHD) requests approval to initiate a new activity for the remaining period of year 3 (March 1, 2024, to August 30, 2024). The new activity is a partnership with the Metro Office of Homeless Services (OHS) to train, deploy and engage 5 additional Community Health Workers to work with recently rehoused residents leaving outdoor encampments in the North and Southeast Davidson County areas. The Metro Office of Homeless Services is a new department (effective July 1, 2023) in Metropolitan Government charged with addressing the city's homeless crisis and preventing chronic homelessness. OHS is currently responsible for executing the city's encampment closure strategy, supporting residents move from outdoor encampments to supportive housing. The city and residents have identified the need for CHWs to support recently rehoused residents' navigation of medical and social services as well as the need for individuals with the lived experience of homelessness to support the city's COVID prevention and mitigation strategies for chronically homeless individuals.

OHS is an entity of the Nashville Metropolitan Government and to form a partnership of interdisciplinary work, would not require a contract but instead a Memorandum of Understanding (MOU). MPHD can avoid long delays due to contracting process by partnering with OHS via an MOU. The MOU process is significantly more efficient, taking approximately 2 months for execution versus 9 to 12 months for contract execution processes. OHS also has capacity to potentially sustain compensation to the Community Health Workers beyond the end of the project period.

Through working with OHS on shared goals, MPHD will be able to reach a larger audience of community members within identified zip codes that may not have access to care due to lack of transportation, inability to establish continuity of care due to moving often and have higher risk of COVID due to environmental factors. Through providing community education, peer support in a 1:1 setting and using the PRAPARE tool to assess needs and provide resource navigation, OHS CHWs allow increased capacity of reaching the original grant goals of Training, Deploying and Engaging CHWs within the Davidson County area. Monitoring of skills, knowledge and community needs will be provided through monthly reports building a case for sustainability of CHWs within OHS. OHS and MPHD have been in monthly communication about this proposed partnership since August 2023 to ensure immediate start if approved. If prior approval is granted for the new proposed activity, the proposed timeline of activities and deliverables includes:

- OHS and MPHD finalize MOU terms

 - Assess health and social service needs via PRAPARE tool
 - Distribute COVID test kits at each encounter with residents
 - Provide residents with personal protective equipment kits (masks, hand sanitizer, gloves, etc.)
 - Assist residents with navigating health insurance access and discuss benefits of COVID vaccination to prevent severe symptoms and hospitalizations
 - o Document resident encounters, needs assessed, and resources provided
 - May serve on the Continuum of Care (CoC) Community Advisory Board and have a standing report to the Homeless Planning Council (individuals elected by the voting body of the CoC and appointed by the Mayor of Metropolitan Nashville)

Role and Activities (highlight COVID prevention, mitigation, and response efforts)

Community Health Workers (CHWs) with OHS will utilize the designated PRAPARE tool to assess the needs of the recently housed community and resources available that are able to meet those needs. OHS community health workers also have a shared lived experience with the community they serve allowing them to serve with empathy, understanding and cultural humility that often cannot be taught.

Training for OHS CHWs will consist of:

- At least three trainings per quarter (Emergency Preparedness, PPE, Motivational Interviewing, Social Determinants of Health, Advocacy, PRAPARE, Cultural Competency, Capacity Building, Care Coordination, Professional Development)
- 2. An OHS personalized training of the PRAPARE tool
- 3. Bi-monthly trainings with all 2109 CHWs for professional development, networking and shared understanding of Davidson County residents' needs

Activities for OHS CHWs will include those of the other 2109 CHWs such as attending community events to provide COVID education, provide test kits and provide PPE and education of their proper usage. Activities specific to the work of OHS consist of providing COVID and VHW messaging at OHS events and community meetings, provide COVID test kits and PPEs to individuals and families that are recently housed and those in the process of being housed, as well as, using the PRAPARE tool as the main identifier of clients' needs.

Other activities will consist of a minimum of two listening sessions focused on program integration and capacity of CHWs to meet community needs, field trips to community specific resources to learn of ways to best help clients navigate resources, as well as advocate for them, and attend the Sustainability Summit in April.

Alignment with the NOFO:

A partnership with Metro Health and OHS for year 3 of the CCR-2109 grant year aligns with the original NOFO through aiding with emergency preparedness of COVID response through utilizing community health workers to aid with:

- 1. Access to Covid education, test kits and resources through 1:1 service, community programming and accessible health messaging
- 2. Directly serving a vulnerable population which is disproportionately impacted by COVID and negatively impacted by social determinants of health and health disparities such as:
 - a. High susceptibility for Covid due to previously existing conditions
 - b. High risk of Covid due to crowded living conditions, lack of access to properly working PPEs and lack of safe, stable, and secure housing
 - c. Lack of access to quality care and continuity of care
 - d. Low community rates of Health Literacy
 - e. High hospitalization needs with lack of insurance and ambulatory care
- 3. Providing training and support to community health workers in a New Division that allows for greater capacity for CHW sustainability post grant award years

General office supplies include postage, print/copy, folders, binders, etc. Finally, \$50 restrictive supply vouchers will be available for recently rehoused residents to obtain necessary move in items such paper towels and cleaning supplies as well as PPE to maintain sanitary living environment to reduce the risk of COVID transmission

c). Travel - \$40,170

Local travel includes mileage reimbursement for CHW team members using their personal vehicle for resident engagement. Local travel also includes bus passes and ride share vouchers for CHW team members who do not have access to personal vehicle to support resident engagement. Bus pass and ride share vouchers also available to residents working with a CHW to obtain COVID related testing, vaccination and to meet medical and/or social needs for stability.

Out of county travel is available to CHW team members for training purposes and to attend the CDC CHW sustainability conference (as appropriate)

d). Training - \$34,200

Training includes professional development opportunities for the CHW team members including completion of the PRAPARE tool training, training on the social determinants of health, use of personal protective equipment, COVID mitigation strategies and community resource navigation.

e). Other - \$24,000
