On behalf of the Metropolitan Planning Commission, the following item, referred to the Commission as required by the Metro Charter, has been recommended for *approval* to the Metropolitan Council:

*A request for the acceptance of 125 linear feet of eight-inch sanitary sewer main, one sanitary sewer manhole, and the relocation of one fire hydrant assembly to serve the 5th and Summer development.*

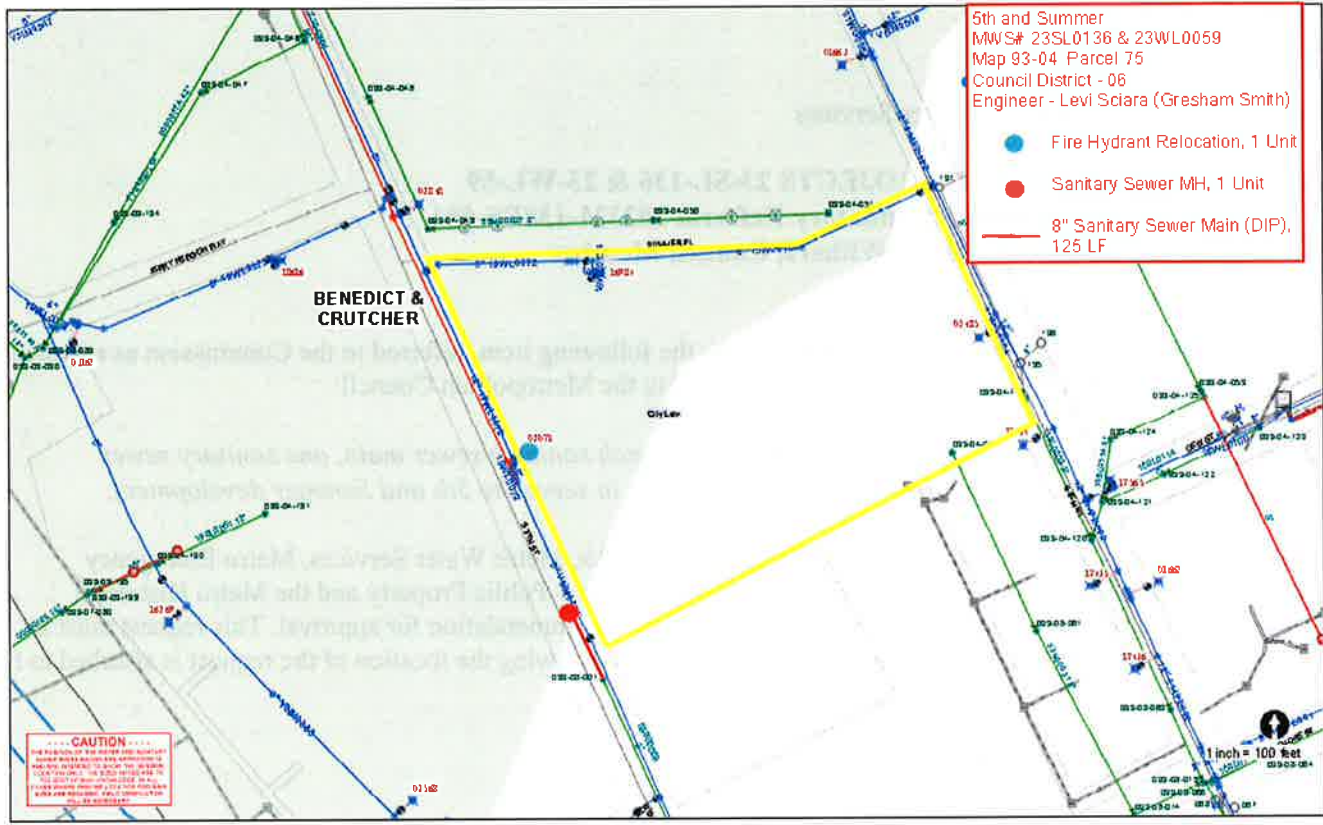

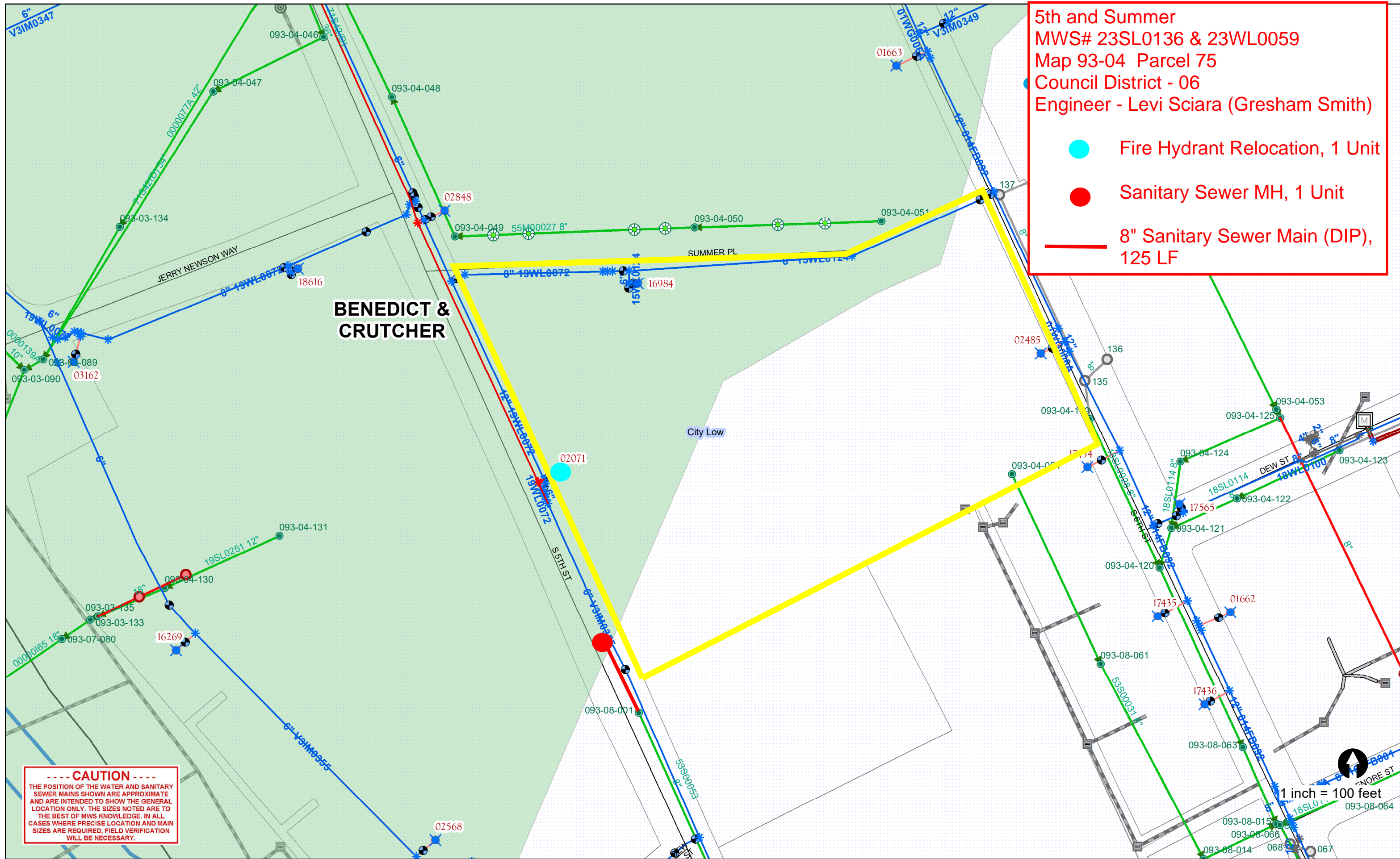
