*A request for the abandonment of approximately 172 linear feet of 8-inch sanitary sewer main, one sanitary sewer manhole, and associated easement to serve the TN Justice Center development.*

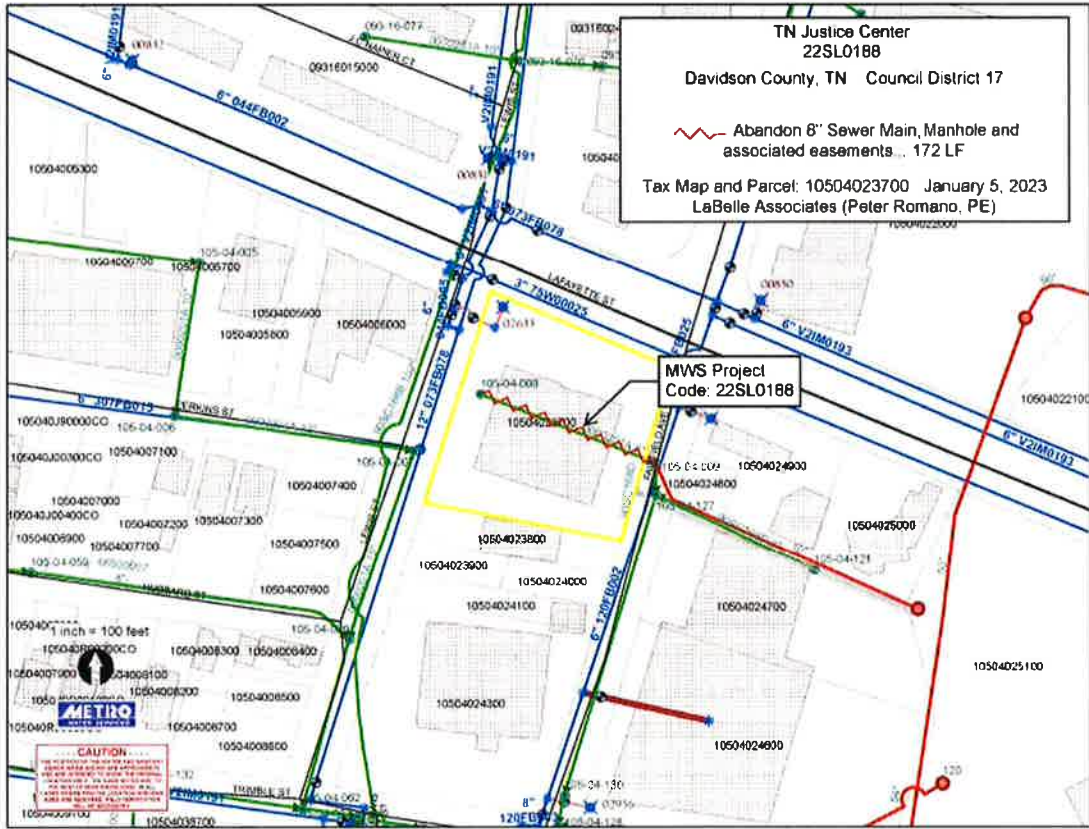

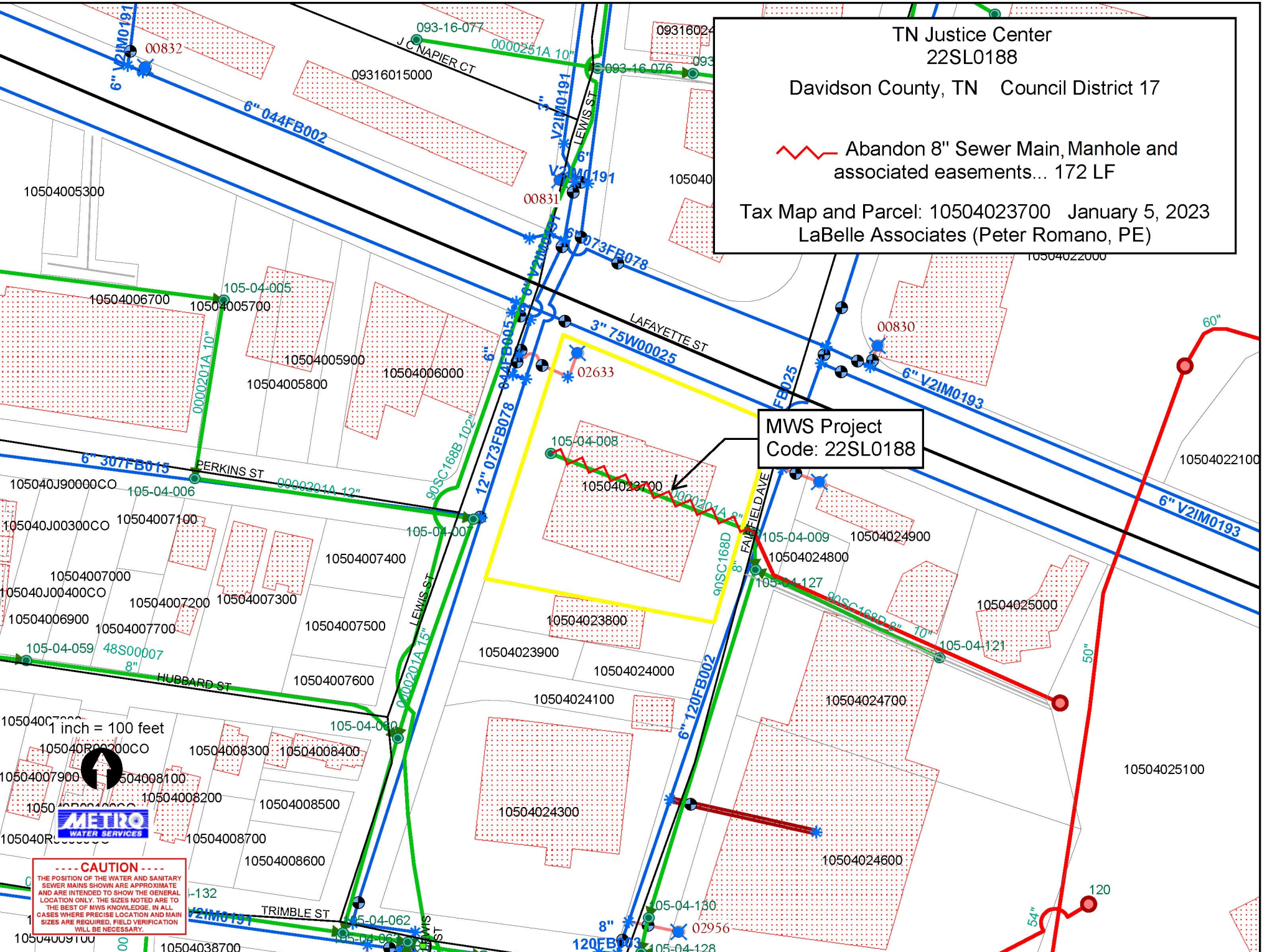
