About the In-kind Grant from Friends of Mill Ridge Park

The in-kind Grant from Friends of Mill Ridge Park, including the design and construction of the Barn at Mill Ridge Park, will have a value of no more than \$1.5M, and will require no matching funds from Metropolitan Government of Davidson County nor the Metropolitan Department of Parks & Recreation. No money will be sent to Metro or Metro Parks. The construction of the Barn will be contingent on the approval by Metro Parks of 1) construction design and documents, and 2) an operating agreement for the Barn involving Friends of Mill Ridge. About the Farm at Mill Ridge Park

Existing on the parkland today is a “remarkably intact farm complex [that] illustrates an early 20th century farm landscape” (Center for Historic Preservation, MTSU). The extant farm buildings, including barns, a chicken coop, an outhouse and well house, composting and dairy processing building, workshops, and smokehouses, need repairs and restoration. The charmingly arranged buildings “offer useful tools for interpreting a rural landscape as it has changed and modernized over the decades.” The plan for the Farm at Mill Ridge, approved by Metro Parks Board in Sept. 2022, envisions restored farm buildings and farmscapes in keeping with their historical nature for interpretive and interactive use by the community. The plan includes a central barn with restrooms (see #1, #2 on plan below) which stands at approximately 5,000 square feet, adjacent to the historic farmhouse information center, community gardens and orchard, farm pond, playscapes, community lawns, and trails.

About the Barn at Mill Ridge Park

Pending approval by the Metro Board of Parks and Recreation, and construction and operation by Friends of Mill Ridge Park, the Barn at Mill Ridge Park (“Barn”) will serve the community in southeast Nashville in a variety of ways while addressing those needs related to the overarching absence of infrastructure and scarcity of amenities, especially those in parks. Set in an idyllic natural space, central to 200,000 Nashvillians, the Barn will offer an alluring gathering space for southeast Nashvillians to purchase local-grown food; participate in nature and park programming; celebrate cultural and faith traditions; and learn the natural, agrarian, and human history of Tennessee.

The Barn will provide a unique space for indoor park and nature programming at Mill Ridge Park, akin to a park nature center. Community research by The Association of Nature Center Administrators revealed nature centers in communities provide community leisure, civic engagement, connection to the environment, and improve community resilience. Beaman, Bells Bend, Shelby, and Warner Parks have thriving nature centers. Southeast Nashville does not have space functioning as a nature center. While the Barn will serve multiple functions at Mill Ridge Park, that of an indoor park program and nature center is an important one. Friends of Mill Ridge Park and other community-based organizations will have access by reservation to the multiple spaces in the Barn to facilitate programming such as nature-based classes, book clubs, and yoga. This will be especially valuable for accommodating park programs that are time of day and weather dependent and for those programs that serve people for whom being outdoors presents barriers. For our community that lacks access to and time in nature, a visit to the Barn for any program activity will offer an immersive connection to nature just by its location.

The Barn will serve as a proximate and accessible event venue. Space to gather in community for cultural traditions and celebrations ranked of high importance by community respondents during the park planning phase. There is a dearth of event spaces in southeast Nashville and those available are often unavailable and too costly for our growing community. The Barn will be available for reservation for a fee for community members and organizations to host quinceañeras, weddings, family gatherings, company meetings, and more. Based on the longstanding and successful model operated by the Friends of Two Rivers Mansion, we will establish an operating agreement with Metro Parks to operate the Barn for event reservations. Nominal revenues will be generated by venue and booth rentals, vendor commissions, event admissions and sponsorships. Program revenue earned by Friends of Mill Ridge Park will support the operation and programming costs of the Barn. The general maintenance and security of the park property and grounds will be the responsibility of Metro Parks in accordance with the approved operation agreement and policies of the Parks Department.

The Barn will offer a market space for local growers to sell produce grown at the gardens at Mill Ridge Park and surrounding areas. This is an important offering because southeast Nashville does not have a community farmers’ market and fresh produce is scarce and expensive in our community. For the community gardens at Mill Ridge Park, where nearly 100 community members grow, there is a waiting list of community members to grow produce they can’t purchase, or produce to sell for supplemental income. A recent pilot of Garden Stands at Mill Ridge Park by The Nashville Food Project (with a “pay what you can” model) generates good participation from community growers and consumers.




- 1 YOUTH CLASSROOM - 300 SF

Architecture firm, Sinz & Shadowens, assessed the barn and designed a flexible configuration to accommodate multiple functions, including spaces for events, educational programs, recreation classes, culinary operations, and farmers' markets, with separate and proximate restroom and parking facilities. Estimates for design, project management, and construction of the Barn will cost less than \$1.5M. To date, Friends of Mill Ridge Park has raised \$1.1M for the construction of the Barn at Mill Ridge Park to date. Friends of Mill Ridge Park will administer the project independently with contracts for third-party project management and construction. We estimate construction of the Barn to begin in 2024 and be completed during 2025.
