On behalf of the Metropolitan Planning Commission, the following item, referred to the Commission as required by the Metro Charter, has been recommended for *approval* to the Metropolitan Council:

A request for the acceptance of approximately 108 linear feet of eight-inch sanitary sewer main (PVC), one sanitary sewer manhole and easement and the abandonment of approximately 1,993 linear feet of 12-inch water main (DIP), 251 linear feet of eight-inch sanitary sewer main (PVC), 222 linear feet of 18-inch sanitary sewer main (PVC) four sanitary sewer manholes, and easements to serve the Nissan Stadium Infrastructure development.

The relevant Metro agencies (Metro Parks, Metro Public Works, Metro Water Services, Metro Emergency Communications, the Nashville Electric Service, Metro Finance – Public Property and the Metro Historical Commission) have reviewed the proposal and concur in the recommendation for approval.
