
This is a resubmission of our proposal that was dated February 13, 2022. It includes comments and feedback from the Metro Parks office.

On behalf of the board of directors of Friends of Woodmont Park, I am submitting a proposal for an improvement to Woodmont Park, 912 Estes Rd., Nashville. Friends of Woodmont Park (FOWP) is a charitable organization that is tax-exempt under section 501(c)(3) of the Internal Revenue Code. Our purpose and mission statement is to be a supporting organization to Woodmont Park. FOWP has enjoyed a close working relationship with Metro Parks for many years and has been able to raise private funds on multiple occasions to provide improvements to Woodmont Park. We are excited about our new project to improve the basketball court in the Park.

#### **Woodmont Park Basketball Court Improvement**

Friends of Woodmont Park proposes to enlarge and improve the basketball court at Woodmont Park. Attached is a copy of the Master Plan for Woodmont Park, which I understand was approved in 2009. We have tailored the proposal to be consistent with this plan. Also attached is a drawing that shows how the project would change the current footprint of the basketball court.

This improvement will make the court more usable for basketball and for other recreational activities. The current court is oriented from north to south. The asphalt surface has a severe slope from one goal to the other, making full court play very difficult. The surface is old, uneven and rough, with many cracks in the asphalt. The current basketball court is shown in the photograph below. It is the asphalt surface to the right (east) side of the tennis court.



The improvement project will do the following:

- Level the surface this will include excavation and removal of the current surface and replace with a new, smooth asphalt surface; we would not reuse the old surface
- Enlarge the surface from 60 feet to 75 foot length east to west
- Reorient the court from north-south to east-west.
- The additional length of the court would go to the west, as shown on the attached illustration.
- If feasible, we would attempt to move the court westward towards the existing tennis court to provide more space on the east boundary of the park for other uses that are in the Master Plan. We will work with the excavation contractor to determine if this is financially feasible.
- Add two new goals for the full court space
- Add shorter goals on the side for children play
- Paint stripes to allow other game uses, including pickle ball

In addition, we would install an ADA compliant sidewalk that would connect the court to the parking lot on Estes Road. The sidewalk would be installed along the north side of the tennis

court, along the yellow line that is shown on the photograph above. By submitting this proposal, we are also submitting to the Metro ADA compliance office for review.

These changes will make the court better for basketball and accommodate multiple uses by kids of all ages. FOWP understands that all design and construction is subject to the approval of Metro Parks staff. Design and construction would be done with oversight and approval of Metro Parks staff. The project will comply with all Metro requirements.

FOWP has undertaken other projects at Woodmont Park that have been successfully implemented and are being enjoyed today. We anticipate that this project would be managed similarly to those past projects.

#### **Financial Information**

- We have received contractor estimates for this project and have had informal discussions with Metro Parks staff. The estimated cost of the project is \$45,000. This cost includes:
  - Removal of current asphalt surface
  - Excavate and level surface
  - Install gravel foundation
  - Install new asphalt
  - Install basketball equipment
  - Paint court striping for basketball, pickle ball and potentially other uses
  - Excavate and install ADA sidewalk.
- An excavation contractor has pledged to support this project and is donating in-kind the excavation phase of the work.
- FOWP would work with Metro Parks but would bid out the remaining work and manage the construction with the assistance of our excavation contractor.
- The completed project would be an in-kind grant from FOWP to Metro Parks.
- The project will require no grant match or other obligation from Metro Parks
- FOWP has already received donations and pledges equal to the estimated cost.

Please let us know if you need additional information. We will be happy to schedule a meeting to discuss the details of the proposal. Thank you for your attention. The neighbors of the park who have supported this are eager to see this project get underway.
