On behalf of the Metropolitan Planning Commission, the following item, referred to the Commission as required by the Metro Charter, has been recommended for *approval* to the Metropolitan Council:

A request for the abandonment of 100 linear feet of six inch sanitary sewer service main and three sanitary sewer manholes and the acceptance of approximately 100 linear feet of eight inch sanitary sewer main (PVC), three sanitary sewer manholes, and associated easements to serve the development at 1007 Thompson Place.

The relevant Metro agencies (Metro Parks, Metro Public Works, Metro Water Services, Metro Emergency Communications, the Nashville Electric Service, Metro Finance – Public Property and the Metro Historical Commission) have reviewed the proposal and concur in the recommendation for approval. 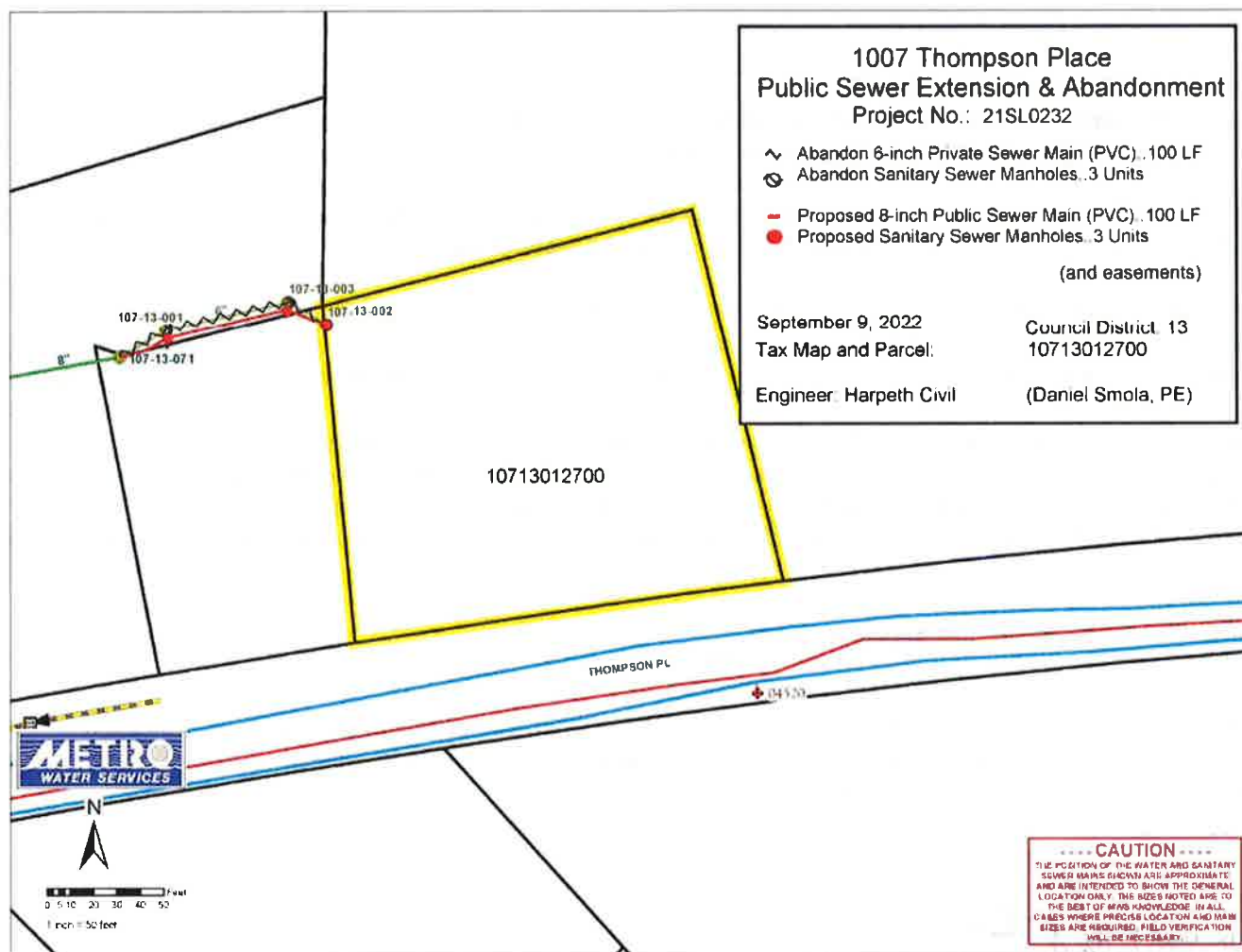
