On behalf of the Metropolitan Planning Commission, the following item, referred to the Commission as required by the Metro Charter, has been recommended for *approval* to the Metropolitan Council:

*A request for the abandonment of approximately 670 linear feet of 12-inch sanitary sewer mains, two sanitary sewer manholes, and easement and the construction of approximately 660 linear feet of 12-inch sanitary sewer mains (DIP) and five sanitary sewer manholes, and the acquisition of permanent and temporary easements for this project near the 28th Avenue North Connector and the CSX Transportation railroad line.*

The relevant Metro agencies (Metro Parks, Metro Public Works, Metro Water Services, Metro Emergency Communications, the Nashville Electric Service, Metro Finance – Public Property and the Metro Historical Commission) have reviewed the proposal and concur in the recommendation for approval. This request must be approved by the Metro Council to become effective. A sketch showing the location of the request is attached to this letter.

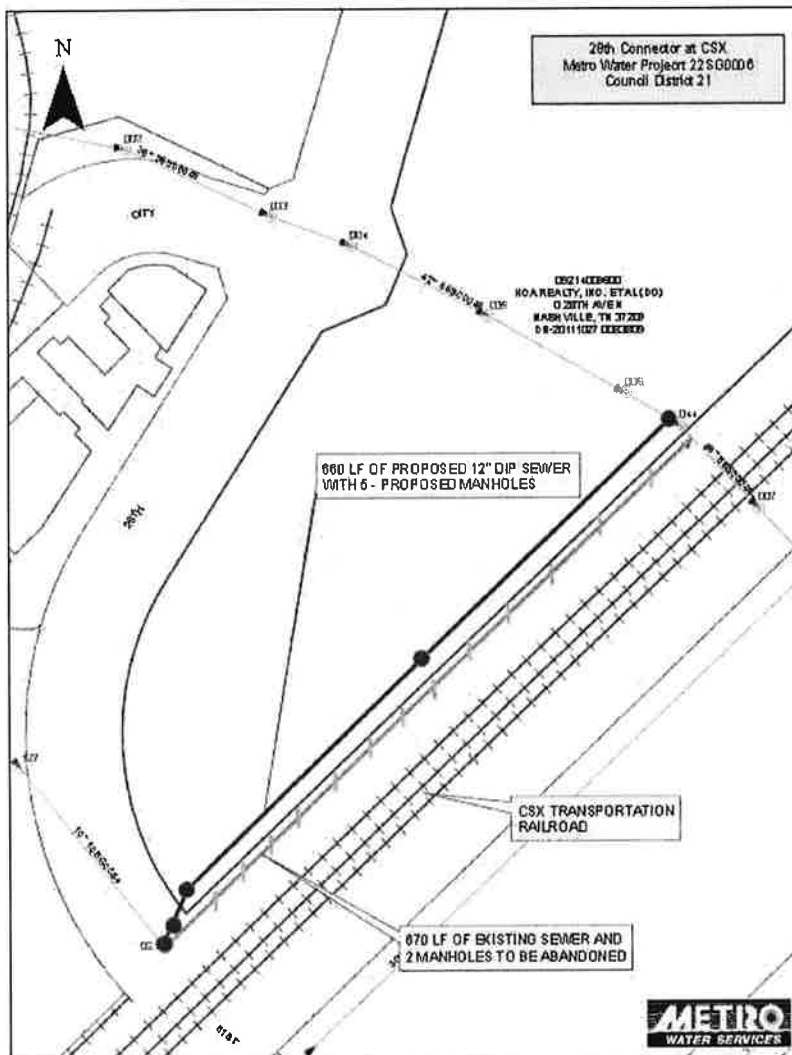
