

THE NOVO ANTIOCH LIFT STATION AND FORCE MAIN OPERATION MAINTENANCE AGREEMENT

THIS AGREEMENT (the "Agreement") is entered into by and between Novo Antioch Owner, LLC ("NOVO"), and The Metropolitan Government of Nashville and Davidson County acting through the Metropolitan Department of Water and Sewerage Services ("METRO").

WHEREAS, NOVO desires to provide a public pressure sewer extension through construction of a private sewage lift station and force main, with the portion of force main inside the public right-of-way becoming public upon completion and acceptance, for its development at 1421 Rural Hill Road, as shown in Exhibit 2, attached hereto; and,

WHEREAS, NOVO has been approved to serve its development using this sanitary sewage lift station and force main, known as Project No. 2022014926, and,

WHEREAS, the provision of such lift station will directly benefit NOVO; and,

WHEREAS, the operation and maintenance of the force main extraordinarily increases the cost to METRO for providing public sanitary sewer service to the development.

NOW, THEREFORE, NOVO AND METRO AGREE AS FOLLOWS:

I. SCOPE OF WORK AND TERMS:

A project consisting of the construction of approximately +/- 1,500 linear feet of 4-inch ductile iron pipe sanitary sewer force main and a lift station (the "Project"). The force main will be located within the public right-of-way of Mt. View Road. The force main will be owned and maintained by Metro upon completion of the Project and acceptance by Metro.

- A. NOVO will contract and oversee construction of the Project, and the lift station design shall meet all METRO specifications and requirements including telemetry and any required repeater sites. The Project shall be constructed and fully operational prior to the issuance of any certificate of occupancy for the Novo Antioch development.
- B. NOVO must submit complete design and construction plans for the Project for approval by METRO prior to commencement of construction.
- C. The Project will be built to METRO standards, and will be subject to inspection by METRO.
- D. NOVO will cause its design engineer to add an air release valve on the force main to delineate between the public and private portion.
- E. NOVO will be responsible for lining and coating the next three downstream manholes on the gravity sewer line on Highlander Drive.
- F. NOVO will provide MWS with a monthly operational report and maintenance schedule of the Project.
- G. NOVO agrees to provide all required easements for the benefit of METRO.
- H. This agreement is subject to the approval through Resolution (one reading) by The Metropolitan Council of Nashville and Davidson County.

II. PAYMENT TERMS AND CONDITIONS:

Prior to commencing any work on the Project, NOVO agrees to provide METRO with evidence of a line of credit in the amount of \$300,000 from a financial institution doing business within the state of Tennessee to cover the repair and maintenance costs of the force main in the public right-of-way for a period of 10 years.

III. FUTURE AMENDMENTS:

Any future amendments to this agreement shall be approved by resolution of the Metropolitan Council.
