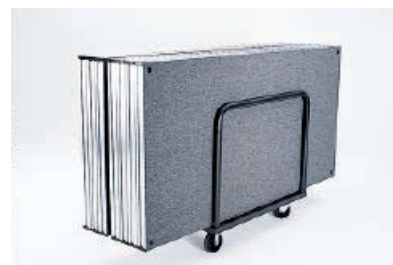

Technical Specifications

Function

Deck shall be portable and provide a playing surface for a variety of indoor events when used in conjunction with, and interchangeably on, various StageRight supports.

Construction

Deck shall be a laminate of high-strength outer layers bonded to a honeycomb core of rigidity and light weight. Deck shall be a 3.2"-thick laminate composite constructed of phenolic-treated cellulose honeycomb between 1/4" solid-core fir plywood. Deck edges shall be closed with a 6005-T5 aluminum extrusion that is clear-etched satin anodized. Corner reinforcement shall be made of high-impact, injection-molded poly-carbonate.

Corners

Deck shall attach by molded corner receptacles to most StageRight supports without tools, clamps or clips.

Reversible

Deck shall be finished on both sides to provide a choice of surfaces and increased wear life.

Quality

Deck as manufactured by StageRight Corporation (address below).

Custom Options

Decks also available in custom sizes, surfaces and shapes. Edging finish with baked-on matte-black coating.

Performance

Certified uniformly distributed live-load capacity of 4000 pounds per 4' x 8' section (125 pounds per square foot).

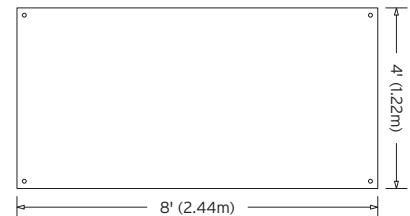

- TechStage Fiberglass sheeting with black textured surface. Excellent wear life and impact resistant. Other colors available by special order. (0.095" thick for performance staging.)

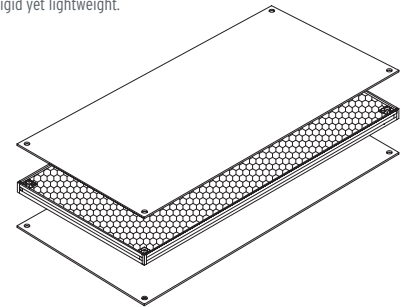
Side View



Top View

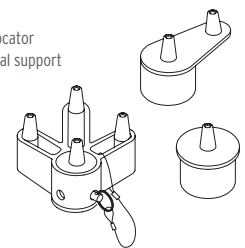


Laminated honeycomb-core construction is rigid yet lightweight.

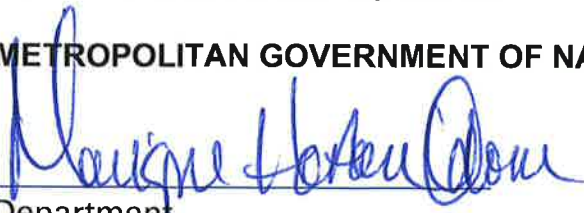

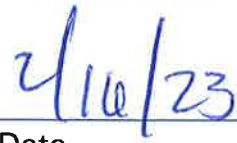

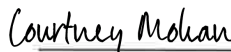
