On behalf of the Metropolitan Planning Commission, the following item, referred to the Commission as required by the Metro Charter, has been recommended for *approval* to the Metropolitan Council:

A request for the abandonment of approximately 1,366 linear feet of four-inch water main, 2,630 linear feet of 2.25-inch water main, 1,385 linear feet of eight-inch water main, and easements and for the acceptance of approximately 48 linear feet of four-inch water main (DIP), 3,728 linear feet of eight-inch water main (DIP), 6,133 linear feet of 12-inch water main (DIP), 14 fire hydrant assemblies and easements, and the replacement of 3 fire hydrant assemblies to serve the Ridgecrest at Vista Offsite development.

The relevant Metro agencies (Metro Parks, Metro Public Works, Metro Water Services, Metro Emergency Communications, the Nashville Electric Service, Metro Finance – Public Property and the Metro Historical Commission) have reviewed the proposal and concur in the recommendation for approval. This request must be approved by the Metro Council to become effective. A sketch showing the location of the request is attached to this letter.

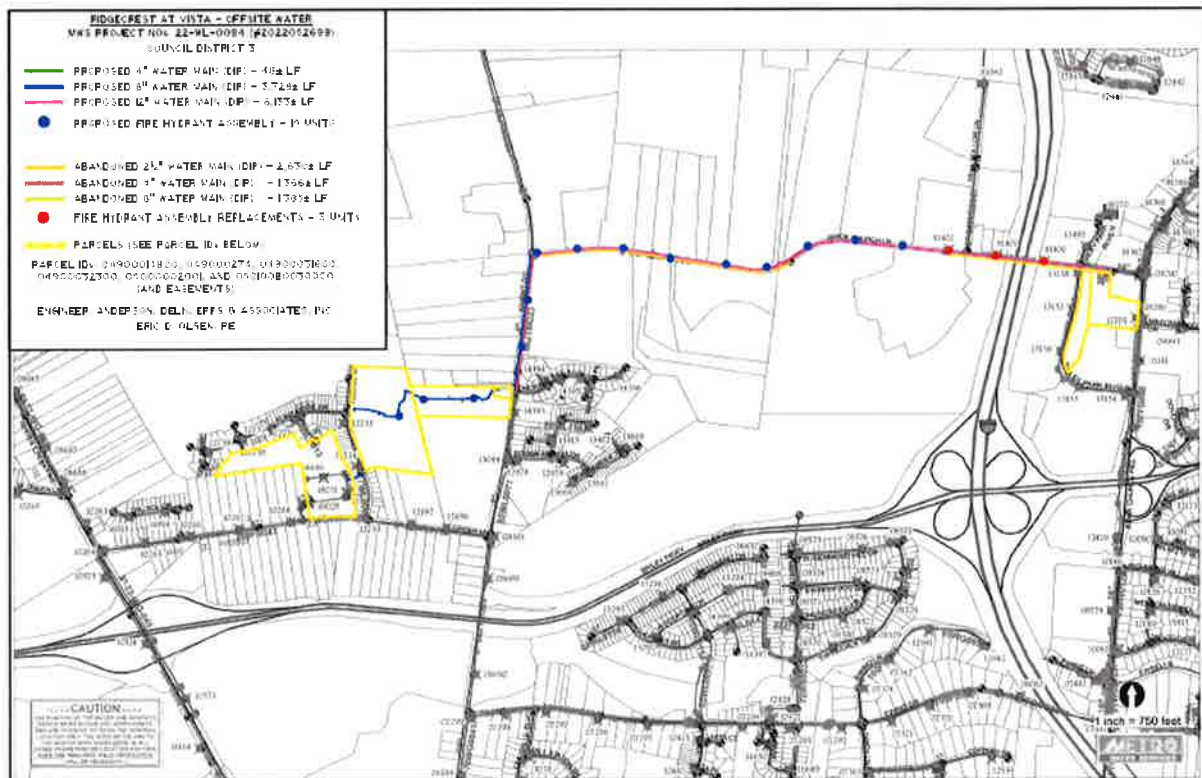
