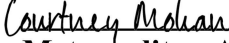

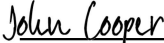

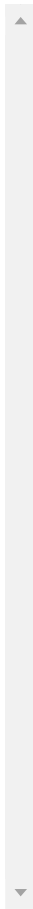

SUMMARY OF PROJECTS

IJ 1- 2

Police Multi Hazard Rapid Maritime Response – Boat/Gear

The purpose is to improve the detection, deterrence, prevention, and response to hazards in the Port of Nashville by the Metro Police. The port waterfront areas are where Nashville lives, works, plays, and has large gatherings.

This investment will provide a multi-use and multi-hazard landing craft style police patrol boat for critical infrastructure water patrols, EOD divers, rescue task force members, SAR members, and tactical operators. This investment also provides bomb protection suits, dive equipment, and community resiliency medical training.

IJ 3

Nashville Fire Department – Boat classes

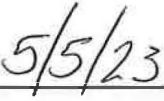

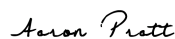
