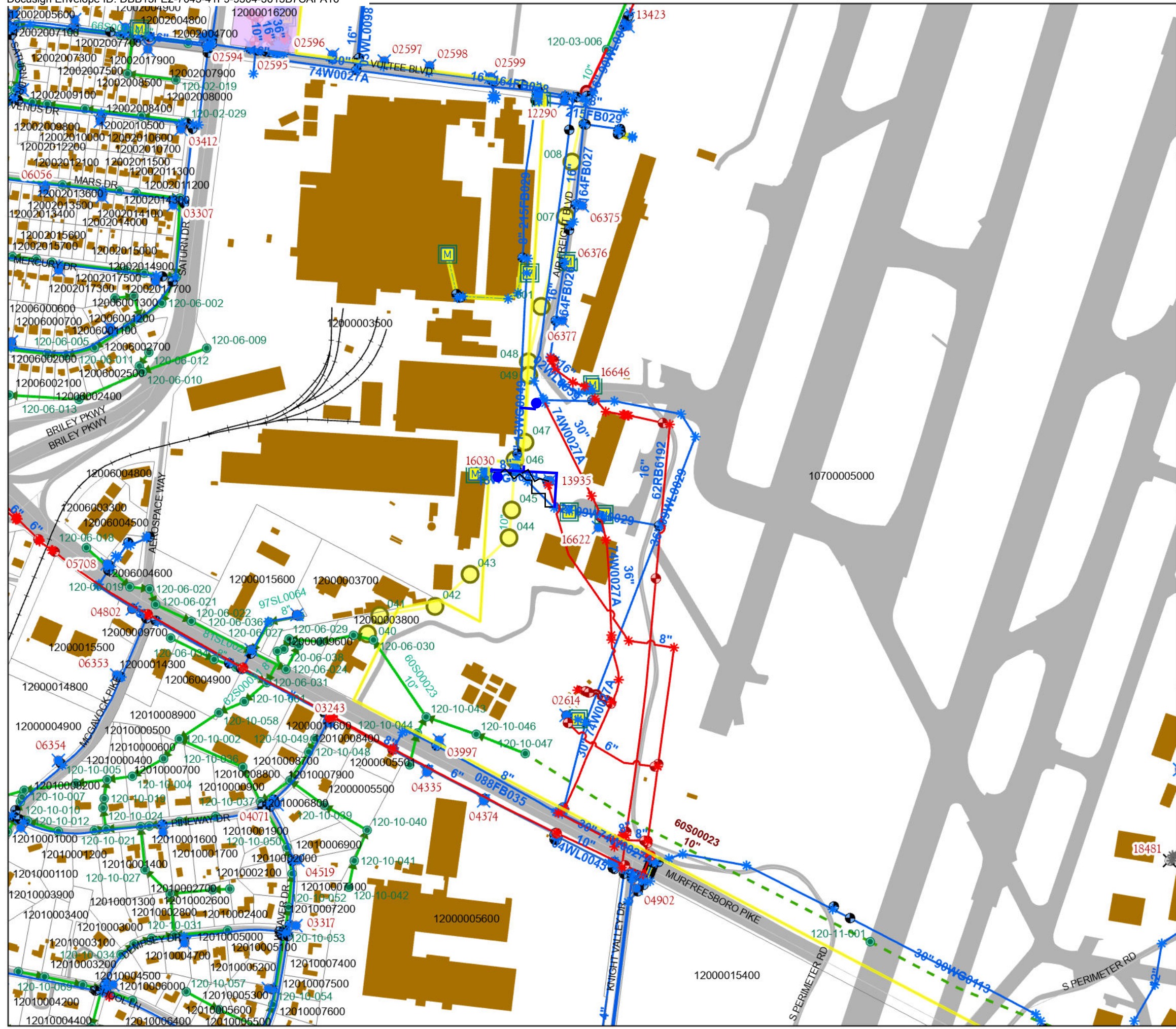

On behalf of the Metropolitan Planning Commission, the following item, referred to the Commission as required by the Metro Charter, has been recommended for *approval* to the Metropolitan Council:

*A request for the abandonment of approximately 325 linear feet of eight-inch water main (DIP), approximately 259 linear feet of 12-inch water main (DIP), and two fire hydrant assemblies and the acceptance of approximately 40 linear feet of 6-inch water main (DIP), 269 linear feet of 8-inch water main (DIP), 349 linear feet of 12-inch water main (DIP), two fire hydrant assemblies and any associated easements to serve the BNA Airport – HCA Hangar and SF Aviation Hangar development.*

The relevant Metro agencies (Metro Parks, Nashville Department of Transportation, Metro Water Services, Metro Emergency Communications, the Nashville Electric Service, Metro Finance – Public Property and the Metro Historical Commission) have reviewed the proposal and concur in the recommendation for approval.
